

either purchased or taken, or both, for said improvements, shall be paid by the City, out of any general funds of the City applicable to said improvement or out of money borrowed for municipal purposes, as may hereafter be directed by the ^{Common} Council; and that the interest and total cost and expense of said improvement and of the cost and expense of the real estate to be used therefor, except said one-half of the cost and expense of the real estate to be used therefor, shall be assessed on the lots and parcels of land to be specially and particularly benefitted by said improvement;

Further Resolved, That the City Attorney be and he is hereby directed, upon the confirmation of the assessment roll for said improvement, to institute proceedings in the Circuit Court for the County of Marquette to acquire said property for said City for the use and purpose aforesaid.

Ayes Alderman Brown Blanchard Barney Hock Hoag Holly Kreis Pundit Rosseter Sherman Stafford Shea Tobin and Vandenberg, The Mayor concurring. Aye none.

Alderman Blanchard moved that the bill of Lovijuy and Demar of \$39 75, for plans for slips of City Hall be allowed, which being supported was lost by the following vote:

Resolved, That the offer of the Douklesley heirs of January 31, 1895, of 50 per cent of the Crescent Street improvement tax in full settlement of the same be and it is hereby respectfully declined.

The Committee on Ordinances rules and legislation, reported and stated that they absolutely failed to find any rule, regulation or ordinance defining duties of the several Standing Committees and ^{after} consulting with the City Attorney, they are of the opinion that no adequate ordinance can be framed for that purpose and asked to be relieved from further consideration of the matter.

Alderman Blanchard moved, which was supported and carried, that the action of the Council relating to said ordinance be rescinded.

On motion of Alderman Shea, it was

Resolved, That a committee be appointed by the Hon Mayor to make all necessary arrangements for the

celebration of the 4th of July in the City of Marquette.

The Mayor thereupon appointed as such George Barnes M. E. Asiro F. J. Jenkinson Rawson Bennett J. P. Werner E. L. Kellan M. C. Scully J. H. Lewis E. E. Nemeier M. O. Turner O. G. Youngquist Alfred Archambeault, A. F. Maynard and E. H. McPherson.

J. O. Clark, of the Marquette City and Piquette I. S. W. Railway Co, addressed the meeting in regard to erecting a depot at the Piquette I. S. W. Park to cost not less than \$1000⁰⁰, and had resolutions prepared for same, when the City Attorney explained that according to the amended City Charter the matter would first have to be referred to the Park and Cemetery Commission, and on motion it was so referred.

Moved by Alderman Sherman, supported and carried that when the Council adjourns it adjourns till Wednesday the 26th day of June A. D. 1895 at 8. O. Clock P. M.

Petition of Frank Bergman to remove his doghouse (since to Meekie's pleasure) garden on the 24th day of June A. D. 1895 from 10. O. Clock A. M. till 7. O. Clock P. M. granted.

Petition of George E. French asking the Council to compensate him for sprinkling the street in front of City Hall and presenting bills for same of \$15⁰⁰ was referred till the next meeting.

An motion of Alderman Tobin the following ^{preambled and} Resolution was adopted.

Whereas, The promoters of a proposed street railway from the passenger depot to the Hotel Superior in this City, and the Marquette City and Piquet Isle Street Railway company have united in asking from the common council the privilege set forth in the following resolution, therefore be it

Resolved, That the owners of the street railway franchise granted by ordinance July 14th 1890, and any party or persons associated with or acting in, by mutual agreement, concert with them for that purpose, are hereby authorized and empowered to construct a street railway with all necessary switches, sidetracks, curves and structures, from a point at or near the passenger depot of the Duluth South Shore and Atlantic railway to a point at or near the Hotel Superior in said City, said railway to be constructed in and upon Superior street, Third street, Fisher street, Champion street, Hendrix street and Blenhuber avenue and also Attamout and Jackson streets at the option of the parties constructing the same. Said road to be operated from June 1. to October 1. in each year and to be constructed with T. rail to

conform to the grades of streets when established and graded; temporary structures in streets not graded necessary to cross hollows therein being hereby permitted until such streets shall be graded, it being understood that said road when constructed shall be operated in accordance with the requirements of said Charter, except as hereinbefore indicated.

On motion of Alderman Stock, Monday July 8th 1895 at 8. O. clock P. M. was fixed for the review, amendment and confirmation of said roll, or its ordering of a new roll by the Common Council. And the Recorder was directed to give the proper notice thereof.

On motion, the following resolution was adopted;

Resolved, That a sidewalk to and the same is hereby ordered to be constructed on the east side of Champion Street from the west side of Geneva Street to the south side of Fisher Street and the respective owners and occupants of the lots or parcels of land on said side of said street, adjoining which said sidewalk is to be constructed, are hereby required within ten days after notice to them as hereinafter provided of this resolution, to construct and make or cause to be made those portions of said sidewalk in front of said lands between the said lines of their respective lots extended at right angles to the course of said street, and the owners and occupants of lots cornering upon streets intersecting said street respectively are hereby required to construct or cause to be made such additional portions of said sidewalk as are located between the nearest curb line of said intersecting streets and said portion in front of said corner lots respectively. Said sidewalk shall be of the uniform width of 5 ft. 4 in, the inner edge thereof to be 4 ft.

from the street line, and the grade thereof to be the same as the grade of the centre of the street upon which the same is constructed opposite the same.

Said sidewalks shall be constructed of good sound pine planks not less than two inches in thickness, and not to exceed eight inches in width laid on at right angles with firmly planted sound pine or hemlock sleepers three inches by six inches in size; the earth to be filled in and firmly packed even with the top of the sleepers; planks to be firmly nailed to the sleepers with at least two spikes not less than twenty penny in size at each bearing; planks to be laid at right angles with the course of the street, at least three such stringers so laid as to break joints.

Notice of this resolution shall be given to the persons required to construct said sidewalks by publication thereof in the minutes ^{of this meeting}.

Resolved, That a sidewalk to and the same is hereby ordered to be constructed on the south side of Cassin Street from the west side of Pine Street to the east side of Fourth Street and the respective owners and occupants of the lots or parcels of land on said side of said street adjoining which said sidewalk is to be constructed, are hereby required within ten days after notice to them, as herein after provided, of this resolution, to construct and make or cause to be made those portions of said sidewalk in front of said lands between the side lines of their respective lots extended at right angles to the course of said street; and the owners and occupants of lots cornering upon streets intersecting said street respectively are hereby required to construct or cause to be made such additional portion of said sidewalk as is wanted between the rear curb line of said intersecting

streets and said portion in front of said corner lot (respectively).

Said sidewalk shall be of uniform width, 5 ft. 4 in., the inner edge thereof to be 4 ft. from the street line, and the grade thereof to be the same as the grade of the center of the street upon which the same is constructed opposite the same.

Said sidewalk shall be constructed of good sound pine plank not less than two inches in thickness, and not to exceed eight inches in width laid on at right angles with firmly planted sound pine or hemlock sleepers three inches by six inches in size; the earth to be filled in and firmly packed even with the top of the sleepers, planks to be firmly nailed to the sleepers with at least two spikes not less than twenty penny in size at each bearing; planks to be laid at right angles with the course of the street, at least three such stringers so laid as to break joints.

A regular meeting of the Common Council of the City of Marquette was held in the Council Chamber on Monday the 1st day of July A. D. 1895. President Sherman presiding.

There were present aldermen Brown, Blanchard, Hook, Hoag, Rosseter, Sherman, Stafford, Shea, Tobin and Vandenberg.

The minutes of the last five preceding meetings were read and approved.

Communication of L. K. Shew Iron Works offering to furnish the City with One (1) 10" x 12" Engine and Boiler complete for Six hundred and seventy two dollars (\$672⁰⁰), also one 10" by 20" Rock Crusher, all complete for seven hundred (\$700), and to allow \$325⁰⁰ for engine and boiler belonging to the City was presented, and on motion the matter was referred to the purchasing committee and the street Commissioner to report at the next Council meeting.

The park and Cemetery Commission reported on the matter referred to it (relating to a passenger depot on Presque Isle), and stated it was deemed very desirable that the Street Railway Company should build a small but good looking structure for a depot or passenger station there, provided that the plan of the structure and its location shall be satisfactory to the Park Commissioners, and on their ^{conditions} recommendation that the prayer be granted. Said report was on motion accepted and ordered placed on file.

Alderman Stafford moved, which was supported and carried that the City attorney draft a proper law or agreement whereby the interests of the City may be protected in the matter and submit it to the park and Cemetery Commission for their approval, prior to their submission of same to the Council.

The committee on Civil Public order and litigation presented partially completed ^{draft of an} ordinance, and asked for further time to report which was granted.

The committee on Pounds, ^{by its chairman} reported and recommended that George Drolek be allowed \$15⁰⁰ for the use of his pound for the season, and on motion of Alderman Brown, the City attorney was instructed to draw up a contract for same.

On motion of Alderman Stafford the Recorder was instructed to procure from the Poundmasters, proper descriptions of the location of the pounds.

The Street Commissioner's report was accepted and ordered placed on file.

Moved by Alderman Stafford, supported and carried, that the Street Commissioner be he is hereby instructed to purchase no more rock for the streets.

Petition to have Division street graded from Jackson street to Strawberry street and water main laid thereon, referred to the street committee.

Petition of Victor Falstedt and thirteen others, to have Hendrix street and Blenshuber avenue graded from Champion street to Altamont street, was presented.

Petition of John Fassbender Jr, and thirty-five others, asking the Council to take such proceedings as deemed best to have Crescent street, between Third and Fourth streets, opened for street purposes, considered later.

Communication from Thomas Proderick was presented offering to deed to the City sixteen feet of land for which he paid \$300⁰⁰ if the City will open Crescent street between Third and Fourth streets, on the condition that the City macadamize the street and lay sidewalks without expense to him, and exempt him from all sewer taxes, as he already has sewer connection which is paid for.

Resolved; That the prayers of the petitioners be granted and that the City Attorney be and he is hereby instructed to draw the proper ordinance covering the said improvements on West Bluff street from West line of Park Avenue to East line of Lincoln Avenue.

The finance committee to which was referred the bid for interest on the city funds recommended the acceptance of the bid of James M. Wilkinson, and on motion of Alderman Schock the following resolution was adopted:

Resolved: That the City Attorney be instructed to prepare a contract between the city and James M. Wilkinson, for the deposit and safe keeping of public money, until April 15, 1896 on the terms of his late bid; said contract to become operative when a bond in the sum of Seventy five thousand dollars, in such form and with such sureties as the Common Council shall approve, shall be filed with the Controller, and said contract to provide for increase in amount of bonds when the Council shall deem the interests of the city require the same:

Resolved: That, when said contract shall be prepared, the Mayor, Controller and Recorder be and they are hereby authorized to execute the same on behalf of the City.

The Street Committee reported as follows:

Your committee to whom was referred the matter of widening the macadamized portions of Fisher and Champion streets would respectfully report that they have had the same under consideration and would recommend that the macadamized portion of Fisher street be widened four feet on each side of said street from the east line of Third street to the west line of Front street and that the macadamized portion of Champion street be widened two (2) feet on each side of said street from the south line of Fisher street to and as far south on said street as the track of the Street Railway extends.

Said report was on motion adopted, and on motion of Alderman Stafford the street commissioner was instructed to do the work as recommended in the report.

On motion of Alderman Tobin the following resolution was adopted:

Resolved, That a sidewalk to and the same is hereby ordered to be constructed on the north side of Michigan street between Spruce street and Pine street, and the respective owners and occupants of the lots or parcels of land on said side of said street adjoining which said sidewalk is to be constructed, are hereby required within ten days notice to them as hereinafter provided of this resolution, to construct and make, or cause to be made those portions of said sidewalk in front of said lands between the side lines of their respective lots extended at right angles to the course of said street; and the owners and occupants of lots cornering upon streets intersecting said street respectively are hereby required to construct or cause to be made such additional portions of said sidewalk as are located between the nearest curb line of said intersecting street and said portion in front of said corner lots respectively.

Said sidewalk shall be of the uniform width of 5 ft 4 in, the inner edge thereof to be 4 ft. from the street line, and the grade thereof to be the same as the grade of the center of the street upon which the same is constructed opposite the same.

Said sidewalk shall be constructed of good sound pine plank not less than two inches in thickness, and not to exceed eight inches in width laid in at right angles with firmly planted sound pine or hemlock sleepers three inches by six inches in size; the earth to be filled in and firmly packed even with the tops of the sleepers; plants to be firmly nailed to the sleepers, with at least two spikes not less than twenty penny in size at each bearing; plants to be laid at right angles with the course of the street, at least three such strings or laid as to tread joints.

Notice of this resolution shall be given to the persons required

to construct said sidewalk by publication thereof in the minutes of this meeting.

It shall be the duty of the Street Commissioner to serve or cause to be served upon each resident owner, and if the owner be a non-resident, upon each resident occupant of each lot or parcel of land in front of which said sidewalk is required to be built, if known to him, a copy of this resolution, either personally or by leaving the same at his place of residence or place of business, if in the city, with any person of suitable age and discretion in his employ, or a member of his household, provided such person shall be found in or upon said premises, but in case no person shall be found upon whom to make said service as aforesaid, then the publication of same in said minutes shall be deemed sufficient.

The bids of John Raepf and son and John J. McPhamara to furnish mouldings in the office of the City Hall, for maps being \$30. each, and the matter of Fly screens, cover on motion, referred to the building committee with power to act.

Alderman Pencil of the purchasing committee, reported and stated that no better bid than that of the Lake Shore Iron works had been received on a rock crusher, but as it had been proposed to dispense with screens he did not feel prepared to report fully at present.

Alderman Rossiter moved, which was supported, that the street committee be allowed till the next meeting to report.

The Recorder read the following communication from the President of the Council James E. Sherman which was on motion ordered placed on file:

"To The Recorder of the City of Marquette:

Dear Sir:-

Mayor Jacobs not having returned to the City, consideration of the Ordinance passed by the Common Council on the 18th, entitled, "An ordinance regulating the construction of Telephone lines within the City of Marquette," has devolved upon me.

This is an enactment purporting to require the placing of all telephone lines in trenches not less than two feet under ground and I herewith returns it to you without approval, my objections thereto being as follows:

1st. The people of this City want cheap telephones.

They have not asked to have the lines put underground and do not desire to pay for any frills of that kind. So far as I am informed and believe, it is not the desire or intention of the Common Council to compel the placing of all telephone lines underground, hence, this enactment lacks all the essentials of good legislation.

2nd. The Ordinance as it stands is so crudely drawn as to lack certainty. Section 1, prohibits telephone lines above the level of the ground "without the permission of the Common Council first obtained". Both the Bell and the Kaufman Franchises as they now stand contain this permission for overhead lines.

Whether any party operating under these two existing franchises could be compelled under this enactment to put their ^{lines} underground is a matter of grave doubt. It is certain none of them would do it unless compelled by legislation. Doubtless the City could afford the expense of all litigation which might be necessary to preserve our public rights, but any such litigation would be in my judgment fruitless and vexatious, unless we

expect and desire that the lines shall go underground.

3rd. The ordinance, as it stands, is on its face in contravention of rights granted by the general statutes of this state; Chapter 102 A. of the third volume of Howell's Compilation, enacted in the year 1883, and I am advised and believe that any attempt to enforce this ordinance against Telephone Companies organized under the statute can result only in defeat, and unless we desire and expect to have all telephone lines placed underground, there is no reason why we should go to any expense to test the matter.

4th. The enactment appears to be without authority of the Legislature of our state. I am advised and believe that the powers of the Common Council in legislating in matters of this kind are strictly limited to the grants of power contained in the words of our Charter and the necessary implication therefrom. Examination of our Charter fails to show any grant of the powers sought to be exercised by this enactment either express or implied. It may be thought by some of that the power granted by our Charter to the Common Council to prevent the encumbering or obstructing of streets, sidewalks, etc., will be sufficient to cover the powers sought to be exercised in this ordinance, but I believe that this is erroneous.

Whatever is prohibited as an obstruction or encumbrance in the street, must be prohibited to all parties alike and the Common Council has not the power, even if it could be supposed to have the wish, to grant to any certain parties privileges in our streets that are prohibited to other parties. See Sec. 35, page 16, of the Charter.

A regular meeting of the Common Council of the City of Marquette was held in the council chamber on Monday, the 7th day of October, A. D. 1895. Mayor Jacobs presiding.

There were present Aldermen Carney, Koch, Hoag, Kolly, Kreig, Pundik, Rosseter, Robertson, Schack, Sherman, Shaw, Tobin and Vandenberg.

Alderman Blanchard appeared later and took his seat.

The minutes of the previous meeting were read and approved.

The Recorder read the following communication from the president of the council, James E. Sherman:

To the Recorder of the City of Marquette.

In the absence of Mayor Jacobs, I have considered the ordinance passed by the Common Council on the 30th ulto., entitled "An Ordinance regulating the construction of Telephone lines within the city of Marquette".

This is an ordinance prohibiting the construction of overhead telephone lines in this city on French Street between Ridge and Superior Sts, and on Washington St, between Fifth and French Sts, brought forward and passed by the Common Council with the sole avowed object of meeting objections recognized as existing against the ordinance passed Sept. 18th, on the same subject, and it was herewith returned to you without approval, my objection thereto being,

1st. There exists no demand on the part of the people of Marquette for the placing of Telephone lines underground in the streets named.

2nd. The ordinance is so drawn as to lack certainty.

3rd. The ordinance is on its face in contravention of rights granted by the State Statute, Chapter 1021 A. of Howell's compilation.

4th. It discriminates in favor of telegraph lines in not including them in its prohibition of such overhead construction in the streets named.

5th. If the ordinance becomes the law of the City on the subject, it will be fruitless of results advantageous to the City of Marquette.

The difference between this enactment and that of Sept 18th, is that of degree only. So far as I can see, the principle is the same.

No citizen of Marquette has in any presence in the Council Chamber, or elsewhere, expressed either demand or argument in favor of the measure, and what legislative powers we possess are not to be used for mere dodging of State Statutes and decisions of State Courts. Furthermore, the people of Marquette are entitled to be taken into our consideration when enactments of such general interest are contemplated.

It is uncertain whether this enactment if valid would result in placing all telephone lines underground on the streets named, or not. It is certain it would not except as the result of judicial determination. Should it result in effect only as to wires hereafter required, then we would have both overhead lines and have our pavement subject to constant digging for underground lines.

If it is desired that the lines go underground on these streets, then all such lines should go underground and the enactment should be made to be certain in this regard.

But I am advised and believe that no such enactment will stand as against Telephone Companies organized under 102. A. Howell, hence all parties undertaking such work here would escape the prohibition by organizing a Company under the law.

The mere fact of having been regularly enacted will not endow our ordinances with the dignity and force of living statutes. Precedents thereto must be a real demand of the public interest to be promoted or conserved and to enter upon legislation without authority and without these prerequisites can result only in disappointment.

A flowage right over practically the same amount of land could be obtained that would very greatly increase the reservoir and permit the dam to be raised six feet, for \$2000⁰⁰, as against \$3000⁰⁰, originally, and that the amount would be paid from the revenue from sale of light.

The following resolution was then, on motion of Alderman Rosseter adopted:

Resolved, That the Light and Power Commission be instructed to procure the land for the electric light power for the sum of Two Thousand Dollars.

Ayes, Aldermen Blanchard, Carney, Hook, Hogg, Holley, Craig Pindell, Rosseter, Robertson, Schock, Sherman, Shea, Tobias and Vandenberg. Nays, none.

The following petition, filed on Oct 7th 1895, and signed by sixty five voters of this City, was then presented:

To the Common Council of the City of Marquette:
Gentlemen: The undersigned, who are qualified voters of the City of Marquette, respectfully petition your honorable body, that an election of the qualified voters of said City be called to determine the question as to whether said City shall remain incorporated under the special act under which it was incorporated, as revised and amended, and by which it is now governed, or whether it shall become subject to the provisions of act No 215 of the Legislature of the State of Michigan of the year 1895, entitled "an act to provide for the incorporation of cities of the fourth class," approved May 27. 1895; and your petitioners will ever pray, etc.

J. M. Longyear presented a communication to the council reporting his attendance to the Deep Waterway convention as delegate from this city and advised that the city be represented in all future gatherings of that character.

Said communication was ordered placed on file.

Petition of residents and property owners on Division and Mc Millan streets, again asking the council that a water pipe be laid on Division street between Jackson & Mc Millan streets, was on motion referred to the water board.

Protest signed by Napoleon Barry and ninety others, protesting against the passage of an amendment to a certain ordinance

in relation to peddling meat on the streets, was on motion referred to the committee on licenses and trade regulations.

Alderman Sherman of the finance committee, to which was referred the bill of the First National Bank for \$300.⁰⁰ rent of the old Recorder's office for the last year it was occupied, reported that the claim was correct so far as to terms and in accordance with the agreement with Mr. White. Said bill was laid over till next meeting of the council.

Alderman Roscuter, of the committee on Railways ^{and} public conveyances, to which was referred the matter of looking after the street railway extension on Washington street, reported that he had seen President Clark, and in view of all the circumstances he was convinced it would not be wise to bring matters at present as Mr. Clark had stated the line would certainly be extended and cars running there next spring.

Alderman Koch stated that complaints had been made of cows running at large in the northern part of the city, etc, and the matter was referred to the committee on Paucels.

Moved by Alderman Sherman, supported and carried, that the Paucel matters be discharged at the end of this month.

On motion the following resolution was unanimously adopted.

Whereas, more than fifty of the qualified voters of this city have filed with the Common Council a petition praying that an election of the qualified voters of the city be called to determine the question as to whether the city shall remain incorporated under the special act under which it was incorporated, as amended, and by which it is governed at this time or whether it shall become subject to the provisions of act No 215 of the laws of Michigan of the Year 1895, approved May 27, 1895.

Resolved, That a special election of the qualified voters of the city be held and conducted as other special elections in said city, upon the 25th day of November 1895, the polls to be opened at the hour of 8. o. clock A. M. and closed at the hour of 5. o. clock P. M. and that said election be held in the several wards of the city at the following places therein:

- First Ward, southwest corner General and Division streets.
- Second Ward, Howard House, Spring St.
- Third Ward, Hodgkins Barn. Pine St.
- Fourth Ward, Police Court, City Hall.
- Fifth Ward, Mr. Engoy's Store, Washington St.

Sixth Ward - Franks' Meat Market, 3rd St. South,
 Seventh Ward, Staffords Green House
 Eighth Ward, On Pine street, south of Stewart Avenue.

Resolved, That notice of said election be given as required by law, and that the controller cause to be furnished a sufficient number of ballots for said election to the inspectors thereof.

Alderman Rossetter offered resolutions for opening Crescent Street from Third to Fourth streets, and for the purchase of a lot on which is a house that blocks the way, for two thousand four hundred dollars, and after discussion, on motion of Alderman Sherman, said resolutions were laid on the table.
