Whereas, Section 6 of the charter of the board of fire and water commissioners of the city of Marquette, makes it the duty of said board to examine and consider all matters relative to supplying the city of Marquette with a sufficient quantity of pure and wholesome water for domestic use, and to provide suitable and efficient means for the extinguishment of fires; and,

Whereas, Section 10 of said charter makes it the duty of said board to purchase lands and materials and reservoirs, buildings, machinery and fixtures deemed necessary to furnish an ample supply of water for public and private use, and also to provide such means as shall give an efficient system of fire protection in the city; and,

Whereas, Said board has full power to raise all the moneys required to make any extensions and improvements desired in the water supply and fire protection systems of the city, and to apportion and levy the expense thereof as they deem proper; and,

Whereas, Said board has long neglected and refused and neglects and refuses to provide any water supply or means for the extinguishment of fires in the large, well peopled and rapidly growing residence section of the city lying along and near Presque Isle Avenue in the vicinity of the Northern State Normal School; and,

Whereas, Four of the six members of said board have this day published an address in which they admit the failure of said board to extend the water supply and fire protection systems to said section of the city and ~~the necessity for such improvements, and~~ seek to justify such failure to make the same upon the ground that owners of property in the locality needing the improvements object to being assessed for such part of the cost thereof as the board deems proper:-

Resolved, That, in the opinion of the common council, said address utterly fails to state any good or sufficient reason or excuse

for the failure of said board to make said improvements; and that, in the opinion of the common council, the health, convenience and safety from fire of many of the inhabitants of the city requires that the water supply and fire protection systems of the city be immediately extended into the section of the city above referred to; and
