Gentlemen: Your special committee to whom was referred the proposed ordinance entitled, "An Ordinance licensing and regulating saloons," beg leave to report that they have had the same under further consideration and as a result thereof have come to the conclusion that it is inadvisable at the present time to provide in such ordinance that a saloon license may be revoked by the council or suspended by the mayor. We learn that it is feared, we think unjustly, that the power to revoke or suspend a saloon license may be oppressively exercised, and that enforcement of the state laws may be relied on to prevent the conduct of the saloon business in an objectionable manner.

We therefore recommend that said proposed ordinance be amended by striking therefrom all of section four and by re-numbering section five so that the same shall stand as section four, and that as so amended that said ordinance be placed upon its passage for adoption.

The records of the sessions of June 1st and 8th, approved.

The petition of Paul Christensen and 45 others, requesting that Sixth street, be graded, curbed and macadamized, from Spring to Fisher streets, was presented.

Moved by Alderman Donovan, supported by Alderman McCarthy, and carried, that the prayer of the petitioners be granted, and that the park, cemetery and street commission have profile made for the grade of said portion of Sixth street.

The petition of Bessie M. Leggett for the withdrawal of the action ordering the laying of new sidewalks on both sides of Crescent street, east of Pine street, was presented and referred to the committee on parks, cemeteries, streets and sewers.

The committee on parks, cemeteries, streets and sewers, recommended that the fire department be granted the use of Spring street, between Fifth and Seventh streets, for holding the races during the "Firemen's Tournament" next August, and that the park, cemetery and street commission be directed to place said portion of Spring street in good condition for said races.

On motion of Alderman Williams, supported by Alderman Schauer, said recommendation was unanimously adopted.

Resolved, That said special assessment roll and the assessments thereon are hereby confirmed, and the sums therein mentioned are hereby levied and assessed against said lots and premises respectively, and the collection thereof is hereby directed.

The controller presented the special assessment roll for the macadamizing of Mesnard street, from the west line of Adams street to the east line of Altamont street, for confirmation.

On motion of Alderman McCarthy, supported by Alderman Donovan, the following was adopted:

Whereas, The recorder has given due notice by publication in The Daily Mining Journal, a public newspaper of the city, that the common council would meet at this time and place for the review, correction and adoption of the special assessment roll for macadamizing Mesnard street, from the west line of Adams street to the east line of Altamont street; and

Whereas, All persons interested in said special assessment roll and the assessments therein having been given an opportunity to be heard in relation

thereto, and the same having been fully considered, and all needful revision and correction of said roll having been made to the satisfaction of the council: .

Resolved, That said special assessment roll and the assessments thereon are hereby confirmed, and the sums therein mentioned are hereby levied and assessed against said lots and premises respectively, and the collection thereof is hereby directed.

Moved by Alderman Williams, supported by Alderman Ekstrom, and carried, that the employment of W. S. Hill and J. E. Ball be authorized to aid in prosecution of the suit of the City of Marquette vs. Bush, in circuit court.

The committee on ordinances and rules presented for adoption an ordinance entitled, "An ordinance authorizing the city treasurer to receive and receipt for certain moneys."

Moved by Alderman Williams, supported by Alderman Schauer, and carried unanimously, that the rules be suspended and that said ordinance be put upon its immediate passage. Said ordinance was, on motion of Alderman Williams, supported by Alderman Ekstrom, adopted by the following vote:
