Gentlemen;-

In the month of November 1909, Honorable H. O. Young, congressman for this District, at an interview held in his office in the city of Ishpeming, between himself and the three then candidates for Post Master in the city of Marquette, William McCormick, John Carlson and John D. Mangum decided to permit the electors of the city of Marquette at the election to be held on the fourth day of April A.D. 1910 to express by ballot their choice between the three candidates for the office of Post Master in the city of Marquette, and agreed to nominate for that office whichever one of the three candidates should **receive** the largest vote at that election. The three candidates agreed to this proposition and agreed to submit their candidacy to such vote and to join and assist in obtaining such vote on the day mentioned. It was understood between all the parties that the machinery for taking this vote should be the same machinery by which the vote upon Circuit Judge and other public questions were taken upon the fourth day of April A.D. 1910 and that each of the candidates would use his best efforts to have the common council of this city authorize the use of the machinery and boards at the various polling places on the fourth day of April A.D. 1910, for this purpose and it was assumed that no opposition would arise to doing this.



Resolved, That there be appropriated for the following purposes for the current year and credited to the respective accounts the following sums of money:

For the use of the park, cemetery and street commission of the city of Marquette the sum of twenty-five thousand dollars.

For the use of the board of police commissioners of the city of Marquette, the sum of four thousand five hundred dollars and that said sums together with the sum of ten thousand five hundred dollars for the general fund of said city, be raised by general tax; and,

Resolved, That the total amount of money to be raised by tax for all local purposes for the year 1910, be and the same is hereby determined to be one hundred thousand and sixty dollars. Exclusive of the one mill tax provided by law and the city controller is hereby directed to levy the same as taxes upon the taxable property of the city of Marquette, on the tax roll of said year as follows:

First, General tax for the general purposes of the city of Marquette and uses aforesaid, forty thousand dollars.

Second. School and one mill tax for the use of the public schools of the city of Marquette, including therein the one mill tax allowed by law as follows: School tax, forty-six thousand dollars; one mill, estimated, six thousand eight hundred dollars.

Third. Library tax, for the use of the Peter White public library of the city of Marquette, the one mill tax allowed by law, viz: Estimated at six thousand eight hundred dollars.

Fourth. Fire and water tax, for the use of the board of fire and water commissioners of the city of Marquette, fourteen thousand and sixty dollars.

Your committee would recommend that of the sum appropriated for the use of the park, cemetery and street commission, five thousand dollars only be expended on parks and cemeteries.
