The Marquette County Board of Commissioners met as a Committee of the Whole on Tuesday, December 12, 1989 at 5:00 p.m. in Room 231 of the Henry A. Skewis Annex, Marquette, MI.

Chairperson Corkin called the meeting to order. Roll call was taken: Present: Comm. Arsenault, Comm. Bays, Comm. DeFant, Comm. Seppanen and Comm. Corkin. Absent: None.

There were no minutes to approve at this meeting.

Chairperson Corkin opened the meeting for public comment. George Sedlacek, 1121 Owaissa, Negaunee, representing the Marquette County Tobacco Coalition, explained that the Health Dept. ordinance to limit vending machine sales of tobacco products is an acceptable compromise to the Coalition. Mr. Sedlacek further added that 100 Marquette County residents die every year as a direct result of tobacco use, and there are over 1,000 kids currently using tobacco in Marquette County, of which 300 of them will die prematurely.

Harvey Wallace, M.D., Professor of Health Education at Northern Michigan University, former Marquette County Health Board Member, and on the Michigan Tobacco Reduction Task Force, pointed out that the State of Michigan is waiting for a model ordinance, such as the one currently proposed before the Marquette County Board of Commissioners. Mr. Wallace added that smoking is the #1 cause of preventable disease in the United States.

Mark Hirvonen, owner of Northern Michigan Vending, believes the compromise ordinance will be detrimental to his business. He also does not want minors to smoke, and is willing to cooperate to limit access to cigarettes for minors, however the strict legal interpretation of the ordinance will cost him many machines throughout Marquette County.

William Short, M.D., 7 Northwood Lane, Marquette Township, has researched the matter of youth smoking. In Dr. Short's survey of 400 high school students, 1 out of 4 teenage girls smoke, and 1 out of 4 boys are chewing tobacco. Mr. Short believes it is our responsibility to do all we can to prevent addiction to tobacco.

Jean Bowman, 313 E. Magnetic, Marquette, is a registered nurse who works to help people to quit smoking. Ms. Bowman stated that kids, despite knowledge to the contrary, will succumb to peer pressure to smoke and chew, therefore access must be limited. She encourages the County Board to adopt the ordinance.

Carol Margrif, 128 Timberlane, Chocolay Township, is the Regional Director of the American Lung Association. 50% of Ms. Margrif's time is spent in Marquette County. The American Lung Association would like to see a ban on all tobacco vending machines, but a start must be made somewhere. The ordinance is better than nothing. There being no further public comment, Chairperson Corkin closed this portion of the meeting.

It was moved by Comm. Arsenault, seconded by Comm. Bays and unanimously carried that the agenda be approved with the following additions; item 17) become the Invoice for the Sewer Extension Project of the County's portion to the Brookridge Project along Co. Rd. 553; and item 18) A Draft Policy regarding Planning and Zoning Assistance to Local Units of Government.

The Committee reviewed Claims and Accounts. It was moved by Comm. Arsenault, seconded by Comm. Seppanen and unanimously carried that claims and accounts for the period November 23, 1989 thru December 8, 1989 in the amount of \$969,082.46 be approved.

The Committee took under consideration the proposed 1990 County Airport Marketing Plan Grant. Charles Hohman, Airport Manager, was present to discuss the grant and answer questions. The grant is for \$50,000.00 and the local share will come from the Airport budget. No additional County funds are required. Mr. Hohman reported that the previous Airport Marketing Grant, with the theme "Fly from Nearby," was very successful, and 90% of the grant was paid by the Michigan Aeronautics Commission.

It was moved by Comm. Arsenault, seconded by Comm. DeFant and unanimously carried that the Committee of the Whole recommend the County Board approve a grant and adopt the 1990 Airport Marketing Grant Resolution.

The Committee took under consideration a Proposed Ordinance from the Marquette County Health Dept. to Limit Vending Machine Sales of Tobacco Products. Chairperson Corkin pointed out that State Representative, Dominic Jacobetti, has requested an Attorney General Opinion on the ordinance, and recommended the Committee delay any action until receiving the Attorney General Opinion. Comm. Seppanen felt that the ordinance could be adopted at this time by the County Board of Commissioners, and asked Civil Counsel if there was any problem regarding such an ordinance. Chief Civil Counsel, David Payant, pointed out that according to MCL 333.2441, the Health Dept. is allowed to adopt regulations necessary and appropriate to implement and carry out its duties. Mr. Payant believes the ordinance to be on firm ground. Randall M. Johnson, M.D., was present and explained that the intent of the ordinance is to limit youth access to vending machines, and believes that many of the vending machines that Northern Michigan Vending claims will be eliminated, could be moved from lobbies, etc. where youth have access, and put into bars where youth are not allowed and there is adult supervision. The Health Dept. initially wanted vending machines banned, but the compromise ordinance will eliminate 90% of the access by youth. Marquette County is breaking new ground in proposing such an ordinance.

It was moved by Comm. DeFant, seconded by Comm. Arsenault and unanimously carried that the Committee of the Whole defer action on the ordinance to limit vending machine sales of tobacco until review of the forthcoming Attorney General Opinion.

The Committee took under consideration a Health Dept. Local Area Network proposal recommendation from Brent Nault, Data Processing Manager. Mr. Nault explained that the Health Dept. has a Texas Instrument Computer System, which is now inadequate and needs to be changed, that was saddled upon them by the State. The Health Dept. proposes the LAN System, which would be entirely funded by grants, and takes advantage of the latest technology in micro computers and fourth generation software. Such systems are so powerful and easy to use, that there is a swing in the computer industry towards local area networks. Mr. Nault contacted several people that have extensive experience in the use of LAN, and has been told that the equipment and hardware that the Health Dept. is proposing is excellent. However, the pricing structure needs some refining. Mr. Nault is recommending that the project be put out on bids because significant savings may be available to the County.

Brent Nault, Data Processing Manager, recommends that the County Board adopt a Local Area Network Proposal for the Health Dept. with the following provisions: 1) Bid the proposed hardware; 2) Revise stages 2 - 5 to accommodate the need for additional software if necessary. The Health Dept. may sacrifice some computing power to remain within the stated project cost, but the two file servers should perform adequately; and 3) Enlist the aid of NMU students to ease the burden on the existing staff, and insure completion within a five year time frame.

It was moved by Comm. Seppanen, seconded by Comm. DeFant and unanimously carried that the Committee of the Whole recommend the County Board approve the Local Area Network Proposal for the Health Dept. as recommended by Staff.

The Committee considered a Health Dept. request to relocate to the New County Office Building (Jacks IGA). Randall M. Johnson, M.D., Director of the Health Dept., was present and explained that the Marquette County Health Dept. has steadily expanded programs and services in recent years, which has created a severe "space crunch" with the Department. The Health Dept. urgently needs space for its present and future needs as the Health Dept. continues to evolve.

In addition, Dr. Johnson explained that moving to Marquette would increase the Health Department's efficiency, and reduce staff travel time and expenses. Approximately two-thirds of the population served by the Health Dept. live east of the Service Center. Relocating into Marquette

would reduce the staff time associated with providing field services, would coordinate Health Dept. services better with other County agencies, and would solve transportation problems for many clients who have difficulty arranging transportation to get to the Service Center.

Dennis Aloia, County Administrator agreed, that the Health Dept. is critically in need of more space, however cannot support its relocation to the Jacks IGA Building. The Service Center building is paid for, and it would make no sense to move into a new building and leave the Service Center with no plans for leasing the space. However, Administrator Aloia is working on a plan and negotiating with Simmons regarding the expiration of their lease in December of 1990. It's a possibility that Simmons may move into the new terminal expansion at the Airport.

It was moved by Comm. Arsenault, seconded by Comm. Bays and unanimously carried that the Committee of the Whole recommend the County Board take no action on the Health Dept. request to relocate to the Jacks IGA Building.

It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the Committee of the Whole recommend the County Board approve the following motion of intent: That the whole Service Center be made available to the Health Dept. as soon as feasible.

The Committee took under consideration a resolution to establish an Alger-Marquette Community Mental Health Services Board Employee Benefit Fund. AMCMH employees have accumulated annual and sick leave, to cover themselves in case of illness or disability, in excess of the amount actually used. The problem for the Community Mental Health Center is that the value of the leave has grown so much that it must be dealt with as a liability. The Michigan Dept. of Mental Health allows the establishment of a separate, distinct fund to finance employee fringe benefits, and to allow the administration of funds when employees separate from the Center. Community Mental Health employees have earned sick and annual leave benefits with an accumulated cash value now of over \$250,000.00. In order to establish the fund, the Community Mental Health Board, along with the Marquette County Board and Alger County Board, must pass a resolution to establish the employee benefit fund.

It was moved by Comm. Seppanen, seconded by Comm. DeFant and unanimously carried that the Committee of the Whole recommend the County Board approve of the Alger-Marquette Community Mental Health Services Board Employee Benefit Fund, and adopt the proposed resolution.

The Committee considered the Henry A. Skewis Courthouse Annex Carpeting Bid Project Recommendation. George Wright, Facilities Manager, was present to present Staff recommendations and answer questions. It was moved by Comm. Arsenault, seconded by Comm. Seppanen and unanimously carried that the Committee of the Whole recommend the County Board approve the Staff recommendation as follows:

That the low bid from Bobby Herron of \$22,898.71, plus Alternate #2 - \$325.80, and Alternate #3 - \$2,136.25, with a contingency of \$139.24 totalling \$25,500.00.

Staff further recommends that \$500.00 be transferred to this project from money remaining in the Jail Camera and Monitoring Project because the total budgeted amount for the carpeting was \$25,000.00.

The Committee considered a recommendation from Dennis Aloia, County Administrator, regarding the trade-in of Sheriff's Vehicles. The 1990 budget has an appropriation to purchase three new Sheriff's vehicles, and annually this amount is calculated, based on expected trade-in of the three oldest vehicles. However, the Employment Programs vehicle, which was originally purchased by the Sheriff's Dept., has 130,000 miles on it and is experiencing maintenance problems. Administrator Aloia recommends that the County Board give the Employment Programs the Sheriff's newest vehicle out of the three he is planning to trade-in, and then use the present Employment Programs vehicle as the third trade-in. The difference in cost may be \$1,000.00 to \$2,000.00, however the final figure will not be known until the bids have been received. Employment Program grants will be used to cover any additional expenses.

Dennis Aloia, County Administrator, further added that the new Building Code vehicle will cost \$9,430.00, without a trade-in, however only \$9,000.00 is budgeted for that purpose. The Employment Programs would like to purchase the unnecessary Building Code vehicle for \$430.00, which will then provide enough funding to purchase the new Building Code vehicle, and also provide another vehicle for the Employment Programs.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault and unanimously carried that the Committee of the Whole recommend the County Board approve the following: To give Employment Programs the newest of the three Sheriff's vehicles which are to be traded in, and then trade in the Employment Programs vehicle as the three trade in; and also approve the purchase of the unnecessary Building Code vehicle by the Employment Programs for \$430.00.

The Committee took under consideration Children and Family Services Legislation. Chairperson Corkin pointed out the legislation has been reviewed by David A. Berns, former Director of the Dept. of Social Services, Randall M. Johnson, Health Dept. Director, and Probate Judge, Michael J. Anderegg. All are opposed to the new legislation. It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the Committee of the Whole recommend that the County Board go on record as being opposed to the proposed Children and Family Services Legislation (H.B. 4251 and substitute versions, and S.B. 109), and that the County Board of Commissioners take a position to support the strengthening of services to children and families within the current delivery system.

The Committee took under consideration the Year-end Budget Review and General Fund Financial Condition Projection Report from Gary R. Yoder, Finance Manager. Mr. Yoder was present and explained that the 1989 Year-end Budget Review has resulted in a favorable projected variance of \$47,674.00. He recommends an increase in the Contingency Account from \$78,986.00 to \$126,660.00 to keep the budget in balance. If there are no major changes in December, the Contingency balance will become part of the Year-end Budget Fund Balance which can be allocated in the 1991 budget process. Commissioners noted with pleasure, that the Social Services Child Care Fund has had a good year, resulting in a reduction of \$74,375.00 in expenditures.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault and unanimously carried that the Committee of the Whole recommend the County Board accept the General Fund Financial Condition Report and approve the recommended Budget Amendments to the County General Fund and other funds, resulting in a favorable projected fund balance variance of \$47,674.00 to be placed in the Contingency Account.

A copy of Ontonagon County's Resolution Opposing Low-Level Radioactive Waste was placed on file. The County Board has previously adopted a similar resolution.

The Committee considered a request from Sheriff, Joseph I. Maino, that the DARE Program be allowed to use \$4,700.00 of the \$15,000.00 FY 1990 budgeted appropriation. Sheriff Maino was present and explained, that although outside funding has not been available yet, the \$4,700.00 would provide the DARE Instruction Program to the five remaining schools who have requested the seventeen-week program. In the meantime the Sheriff will continue to seek outside funding as part of a Kellogg Foundation Grant, and also seek funding from the school districts for the 1990 Fall semester. The Committee, Sheriff Maino, and Administrator Aloia discussed at length various possibilities for coordinating the DARE Program with other municipalities and its funding. It was moved by Comm. Arsenault, seconded by Comm. Seppanen and unanimously carried that the Committee of the Whole recommend the County Board approve the use of \$4,700.00 of the \$15,000.00 FY 1990 budgeted appropriation for the DARE Program for the Sheriff's Dept.

The Committee considered the invoice for the Sewer Extension Project along Co. Rd. 553 to the Brookridge Facility. Dennis Aloia, County Administrator, explained that this was part of the project approved by the

County Board, whereas the City of Marquette, Developer Lynn Swadley, and Marquette County would each pay a portion of the Sewer Extension costs. The Marquette County portion is \$5,000.00, which may be paid out of the proceeds from the sale of Brookridge or the building's insurance account. It was moved by Comm. Seppanen, seconded by Comm. Bays and unanimously carried that the Committee of the Whole recommend the County Board pay their portion of the Sewer Extension along Co. Rd. 553 to the Brookridge Property, amounting to \$5,000.00, and that the funds be taken from the Building Insurance Account.

The Committee took under consideration a proposed policy regarding Planning and Zoning Assistance to local units of government. A memo from Gwen Timmons, Chairperson of the Marquette County Planning Commission, explained that the Planning Commission's understanding is that the County Board wishes to define the role of the County and its departments, in its relationship between the local units of government, regarding planning and zoning matters. The policy is necessary for the administration of costs, access to County Staff, consistency in enforcement, and reducing fragmentation in future zoning matters when dealing with the local units. The Committee discussed draft Planning and Zoning Policy at length, and made some amendments to the first paragraph. It was moved by Comm. Seppanen, seconded by Comm. Arsenault and unanimously carried that the Committee of the Whole recommend the County Board adopt the policy on County/Township Planning and Zoning matters as amended.

Chairperson Corkin opened the meeting for public comment. Mark Hirvonen, Northern Michigan Vending, again addressed the Committee regarding the Proposed Ordinance Limiting Vending Machine Sales of Tobacco. Mr. Hirvonen thinks the ordinance is very clear and will result in the loss of machines, even though Dr. Johnson of the Health Dept. interprets it more loosely. Mr. Hirvonen does not like the language as written, and would like some changes made.

The Committee suggested that Mr. Hirvonen submit his suggested wording changes to the County Clerk for consideration at the January 9th Committee Meeting, and it will addressed along with the Attorney General Opinion. There being no further public comment, Chairperson Corkin closed this portion of the meeting.

There being no further business to come before the Committee of the Whole the meeting was adjourned.

89-47 MARQUETTE COUNTY RESOLUTION RE: EMPLOYEE HEALTH BENEFITS FUND

WHEREAS, the Governmental Accounting Standards Board, whose pronouncements are accepted as authoritative in matters of governmental finance and accounting by the Michigan Department of Treasury, requires the recognition of liabilities arising out of the accumulated unpaid leave earned by employees of units of government; and

WHEREAS, the Alger-Marquette Community Mental Health Services Board desires to provide funds adequate to cover the unpaid leave and other benefits of its employees; and

WHEREAS, in accordance with policy of the Michigan Department of Mental Health, Volume IV, Sec. 001, Chapter F, 001 dated November 7, 1985, State funds may be used to partially fund such a reserve only if a separate, segregated fund is established to finance fringe benefits for employees of community mental health boards; and

WHEREAS, the Alger-Marquette Community Mental Health Services Board has agreed to take advantage of this provision and desires to establish an internal service fund;

THEREFORE BE IT RESOLVED, that the Marquette County Board of Commissioners and the Alger County Board of Commissioners directs the Treasurer of Marquette County to establish and maintain a separate, segregated fund, to be known as the ALGER-MARQUETTE COMMUNITY MENTAL HEALTH SERVICES BOARD EMPLOYEE BENEFIT FUND, which shall be funded by the Alger-Marquette Community Mental Health Services Board in an appropriate manner from funds available to it for such purposes; and

FURTHER, that the Alger-Marquette Community Mental Health Services Board Employee Benefit Fund shall be restricted exclusively to the payment of employee fringe benefits and related costs, in accordance with the policies of Alger-Marquette Community Mental Health Services Board to the full extent of any such liability; and

FURTHER, that any income generated by the Alger-Marquette Community Mental Health Services Board Employee Benefit Fund shall become a part of that Fund and shall be restricted to the purposes of the Fund as described above; and

FURTHER, that if the Alger-Marquette Community Mental Health Services Board Employee Benefit Fund should possess assets in excess of its liabilities, such assets may be used to reduce future expenses for employee benefits and other expenses of the Alger-Marquette Community Mental Health Services Board; and

FURTHER, that in the event of dissolution of the Alger-Marquette Community Mental Health Services Board, assets of Alger-Marquette Community Mental Health Services Board Employee Benefit Fund remaining in excess of its liabilities shall be disposed of in accordance with law and the policies of the Michigan Dept. of Mental Health and the Alger and Marquette Two-County Agreement, dated 5/5/82.

It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the County Board concur with a Committee of the Whole recommendation and adopt the following policy on County/Township Planning and Zoning Matters:

POLICY ON COUNTY/TOWNSHIP PLANNING AND ZONING MATTERS

- Local units of government have the right to adopt their own Comprehensive Plans and Zoning Ordinances consistent with Public Acts 184 of 1943 and 168 of 1959 as amended.
- 2) The County shall adopt a County Zoning Ordinance based upon a County Comprehensive Plan which shall be enforced and administered in all Townships which elect not to adopt and enforce their own ordinance.

- 3) The Resource Management/Development Department shall make available upon request by a local unit of government, any information and maps in its possession which would facilitate preparation of a comprehensive plan or zoning ordinance. The Department may recoup costs for reproduction of materials. The local unit will be expected to acknowledge the source of data and base maps used in preparing their final documents.
- 4) The Resource Management/Development Department and/or the Marquette County Planning Commission shall provide informal review of draft ordinances and plans upon request.
- 5) The Marquette County Planning Commission will provide formal review of proposed ordinances consistent with Sections 10 and 14 of Public Act 184 of 1943 as amended and adopted plans consistent with Sec. 8 & 9 of Act 168 of 1959 as amended.
- Reviews conducted by the Marquette County Planning Commission and the Resource Management/Development Department shall take into consideration the County Comprehensive Plan, any applicable local plan, state planning and zoning laws, generally accepted planning principles, case law and the physical and cultural characteristics of the areas involved. Resulting comments are recommendations only. Local units are encouraged to have their own legal advisors review plans and zoning ordinances for form, enforceability, and liability.
- Local units of government desiring in-depth assistance (such as map preparation or drafting of major portions of ordinance or plan text) shall submit a written request to the Director of the Resource Management/Development Department. The Director, in consultation with the County Administrator and Marquette County Planning Commission, shall negotiate a written contract between Marquette County and the local unit of government. Due regard shall be given to time commitments of staff and budget considerations. Efforts will be made to address such large scale projects through Planning Commission budget oversight Policy 87-2. Final approval of the contract will rest with the County Board of Commissioners.

Adopted this 19th day of December, 1989.

It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the County Board concur with a Committee of the Whole recommendation and adopt the 1990 Airport Marketing Grant Resolution and authorize the Board Chairperson to sign the Grant Application.

MICHIGAN STATE DEPT. OF TRANSPORTATION MARKETING GRANT RESOLUTION

WHEREAS, a Grant offer for Air Service Marketing Projects is being initiated between Marquette County and the Michigan Dept. of Transportation for the promotion of the Marquette County Airport, and its air service.

WHEREAS, it is conditioned on the approval of the Marquette County Board of Commissioners; and

WHEREAS, it is necessary for the Chairperson of the said Board of Commissioners to execute the marketing contract on behalf of the County Board of Commissioners;

THEN BE IT RESOLVED, that the Marquette County Board of Commissioners at its December 19, 1989 regular meeting does take action to authorize the Chairperson to sign the Marketing Grant Contract and all associated documents necessary to initiate said Grant following review by the Prosecuting Attorney's Office when such completed forms, reports and documents are available for signature.

GERALD O. CORKIN, CHAIRPERSON MARQUETTE COUNTY BOARD OF COMMISSIONERS

The County Board took under consideration a recommendation from the Committee of the Whole to approve a Local Area Network (LAN) Computer proposal for the Health Dept. Brent Nault, Data Processing Manager, recommended that the County Board adopt the proposal with the following provisions; 1) Bid the proposed software; 2) Revise stages 2 - 5 to accommodate the need for additional software if necessary. The Health Dept. may sacrifice some computing power to remain within the stated project cost, but the two file servers should perform adequately; and 3) Enlist the aid of NMU students to ease the burden of the existing staff, and ensure completion within a five-year time frame.

County Administrator, Dennis Aloia, presented a revised 1989 budget amendment #4 for the Health Department. Administrator Aloia explained that the recommendation and the budget amendment amount remains the same, however it will be split between two line items. It was moved by Comm. Seppanen, seconded by Comm. Arsenault and unanimously carried that the County Board approve the recommendation from the Committee of the Whole for the proposal Local Area Network Computer System (LAN) for the Health Dept.

The Chairperson declared the motion carried and the resolution duly adopted.

It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the County Board concur with the Committee of the Whole and approve payment for the County share of the Sewer Extension Project along Co. Rd. 553 to the Brookridge Property in the amount of \$5,000.00, and that funds be taken from the Building Insurance Account.

The County Board took under consideration a recommendation from the Committee of the Whole opposing Proposed Children and Family Services legislation. The Legislation was reviewed by David A. Berns, Former Director of the Dept. of Social Services, Randall M. Johnson, Health Dept. Director, and Probate Judge, Michael J. Anderegg. All were opposed to the new legislation, and recommended that Children and Family Services be strengthened within the current system. It was moved by Comm. DeFant, seconded by Comm. Seppanen and unanimously carried that the County Board concur with the recommendation and go on record as being opposed to the Proposed Children and Family Services Legislation (House Bill 4251 and Substitute Versions, and Senate Bill 109), and that the County Board of Commissioners take a position to support the strengthening of services to children and families within the current delivery system.

The County Board considered the resignation of Edward Kinkella from the Economic Development Cooperation for the County of Marquette, effective December 31, 1989. It was moved by Comm. Arsenault, seconded by Comm. Seppanen and unanimously carried that the resignation be accepted, and that a Certificate of Appreciation be forwarded to Edward Kinkella by the County Clerk on behalf of the Board of Commissioners, and that the vacancy in the at-large category on the EDC be advertised and filled as soon as possible.

The County Board took under consideration the award of the Worker's Compensation Bid for 1990. Dennis Aloia, County Administrator, introduced Cyndi Beaudry, Administrative Assistant. Ms. Beaudry has been working 3/4 time on insurances, and her work has led up to the recommendation being presented, which will result in a savings of \$80,000.00 to \$85,000.00 per year on worker's compensation insurance premiums.

Cyndi Beaudry, Administrative Assistant, reviewed the procedures followed in securing the bids for the County Commissioners. The bids were requested in five options. The first option was all of Marquette County including the Alger-Marquette Community Mental Health, the Valente Medical Care Facility, and the County Health Dept. Option Two was a separate bid for Alger-Marquette Community Mental Health. Option Three was a separate bid for the Medical Care Facility. Option Four was a separate bid for the Marquette County Health Dept. Option Five was a separate bid for the remainder of the County. The County received four bids, one each from Elder Agency on behalf of the Accident Fund, Consolidated Risk Management Services on behalf of the Michigan Municipal Workers Compensation Fund, Citizens Insurance Company through Michigan Association of Counties, and a bid to provide Administrative Services for a self-funded insurance program from Consolidated Risk Management Services.

Staff analyzed all the proposals. Marquette County is not in a position, at this time, to consider a self-insured worker's compensation program. Our current budget falls approximately \$100,000.00 short, and further research and investigation is necessary before we can fully realize the benefits of providing worker's compensation insurance through a self-The bid received from Citizens Insurance was \$60,000.00 funded program. over the low bid. Second, Marquette County has had worker's compensation insurance with the Accident Fund for the past four years, however during that time (with the exception of 1985-1986 when a dividend of \$14,379.34 was paid), the County has received no dividends from this program. The Michigan Municipal Workers Compensation Fund has provided the City of Marquette with substantial dividend returns on their annual premium since 1983, averaging approximately \$56,000.00 in dividends per year, which is about 50% of the premium being returned.

It is the Staff's recommendation that the Worker's Compensation Insurance bid be awarded to the Michigan Municipal Worker's Compensation Fund as provided through Consolidated Risk Management, Inc., at the rate of \$17,842.00 for the Health Dept., and \$58,846.00 for the County. (Alger-Marquette Community Mental Health and the Valente Medical Care Facility will go on their own. It is further recommended that the County join the Michigan Municipal League at a cost of \$600.00 annual dues, and further that Staff be allowed to continue to negotiate with the Michigan Municipal Worker's Compensation Fund on future insurance premiums.

It was moved by Comm. Seppanen, seconded by Comm. DeFant and unanimously carried that the County Board approve the Staff recommendation as presented. The County Board further commended Staff, especially Cyndi Beaudry, Administrative Aide, for the excellent job in reviewing the Workman's Compensation Insurance, and saving the County thousands of

Administrator Aloia indicated that Ms. Beaudry will be continuing her work on other types of insurance, which will provide even more savings in the future for Marquette County.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault and unanimously carried that Claims and Accounts for the period December 9, 1989 through December 19, 1989, in the amount of \$810,298.79 be approved.

Chairperson Corkin opened the meeting for public comment. Wes Larson, Negaunee Township Supervisor and Part-time Director of the Marquette County Townships Association, was present and indicated that the Townships Association Executive Board is studying the Humane Society contract proposals. Mr. Larson further questioned the implementation of the 9-1-1 Proposal. It seems there has been some difficulty with Michigan Bell regarding the grid system and the use of existing addresses.

Comm. Arsenault, a member of the 9-1-1 Implementation Committee, said he is aware of the problem and a meeting is scheduled some time in January where it will be further discussed. Comm. Arsenault added that when a 9-1-1 coordinator is hired, many problems will be resolved. Comm. Arsenault will follow through with further developments and report to Wes Larson.

Chairperson Corkin announced that the Executive/IGR and the Finance/Personnel Committee meetings scheduled for December 26, 1989 are cancelled. The County Board will hold it's organizational meeting on Tuesday, January 9, 1990 at 7:00 p.m., and the County Board will also meet as a Committee of the Whole on January 9, 1990 at 5:30 p.m.

On behalf of the County Board of Commissioners, Chairperson Corkin wished everyone a Merry Christmas and Happy New Year!

There being no further business to come before the County Board the meeting was adjourned.
