GERALD O. CORKIN, CHAIRPERSON MARQUETTE COUNTY BOARD OF COMMISSIONERS

Chairperson Corkin opened the meeting for public comment. Earl Yelle, Sands Township Supervisor, was present and thanked Commissioner Geraldine DeFant for her excellent service to Marquette County. She represented Sands Township very well over the years and always took the time to answer questions and discuss concerns with Supervisor Yelle. Mr. Yelle extended, on behalf of Sands Township, their best wishes for Commissioner DeFant's retirement. There being no further public comment, Chairperson Corkin closed this portion of the meeting.

On a motion by Comm. DeFant, seconded by Comm. Arsenault, the agenda was unanimously approved with the following changes: that action items 10e) and 10f) be removed from the agenda to be presented at a future meeting.

Privileged Comment

Jonathan S. Mead, Executive Director, Upper Peninsula Commission for Area Progress Services, Inc. (UPCAP), was present to request Marquette County's support and explain the benefits of membership with the UPCAP organization. Over the past several years, fourteen of the fifteen U.P. Counties have been active members of UPCAP. Their support has been crucial to UPCAP's growth and success, as well as the ability to serve U.P. residents. Marquette County has not chosen to participate in UPCAP since 1978, however Mr. Mead feels UPCAP must accept the responsibility for Marquette County's lack of involvement. Mr. Mead thanked the County Board for the opportunity to meet with them and review UPCAP's recent accomplishments and benefits of membership to UPCAP.

AMENDMENT TO ARTICLE V OF THE ARTICLES OF INCORPORATION OF MARQUETTE COUNTY BUILDING AUTHORITY

This Amendment to Article V of the Articles of Incorporation of the Marquette County Building Authority is adopted by the Board of Commissioners of the County of Marquette, Michigan, being the legislative body of the County, for the purpose of amending said Article V pursuant to the provisions of Act No. 31, Public Acts of Michigan, 1948 (First Extra Session), as amended ("Act 31").

ARTICLE V

Commission

- Section 1. The Authority shall be directed and governed by a governing body consisting of three members known as the "Commission." Each member of the Commission shall be appointed by the Chairman of the Board of Commissioners of Marquette County and approved by a majority of the Board present and voting at a lawfully held meeting of the Board. No member of the Board shall be eligible for membership or appointment to the Commission.
- Section 2. The first members of the Commission appointed shall serve a term ending December 31, 1989. Each member of the Commission appointed thereafter shall serve a three-year term. Except for the first members appointed by the Board and any member appointed to fill a vacancy as provided in these Articles of Incorporation, the three-year term of each member shall commence on January 1 and expire on December 31 of the second year following the year during which such term begins.
- Section 4. Vacancies on the Commission occurring for any reason (including vacancies resulting from an increase in the number of members of the Commission by amendment of these Articles of Incorporation) shall be appointed by the Chairman of the Board of Commissioners of Marquette County and approved by a majority of the Board present and voting at a lawfully held meeting of the Board. Any member appointed to fill a vacancy on the Commission shall serve for the unexpired term of the members of the Commission remaining in office at the time such appointment is made.

 $\underline{\text{Section 5}}$. The Commission shall designate one of its members as Chairperson of the Authority and one of its members as Secretary of the Authority, each to be designated for such term in office as may be fixed by the Commission.

Section 6. The Chairperson shall preside at meetings of the Commission; shall sign and execute all authorized bonds, contracts, checks and other obligations in the name of the Authority when so authorized by the Commission; and do and perform such other duties as may be fixed by the bylaws and from time to time assigned to the Chairperson by the Commission. The Chairperson may cause his or her facsimile signature to be affixed to bonds issued by the Authority and any interest coupons attached thereto, if so authorized by resolution of the Authority.

Section 7. The Secretary shall keep the minutes of all meetings of the Commission and of all committees thereof, in books provided for that purpose; shall attend to the giving, serving and receiving of all notices on behalf of the Authority; may sign, with the Chairperson in the name of the Authority, all contracts and bonds, if so authorized by the Authority thereto if a seal has been adopted. The Secretary may cause his or her facsimile signature to be affixed to bonds and any interest coupons attached thereto, if so authorized by resolution of the Authority. The Secretary shall preside at meetings of the Commission in the absence of the Chairperson and in general perform all the duties incident to the office of Secretary.

Section 8. The Treasurer of the Authority shall keep all books and records of account of the Authority. The Treasurer may be but need not be a member of the Commission. The Treasurer shall have custody of all the funds and securities of the Authority which may come into his or her hands. When necessary or proper, the Treasurer shall endorse other obligations and deposit them to the credit of the Commission; shall sign all receipts and vouchers for payments made to the Authority; shall jointly, with such other officer as may be designated by the Commission, sign all instruments of the Authority when so ordered by the Commission; shall render a statement of the Authority's cash accounts when required by the commission; shall keep full and accurate accounts of all monies received and paid by the Treasurer on account of the Authority; and shall at all reasonable times exhibit his or her books and accounts to the Commission, or any member thereof, when so requested. The Treasurer shall perform all acts incidental to the position of Treasurer fixed by the bylaws and as assigned from time to time by the Commission. The Treasurer shall be bonded for the faithful discharge of his or her other duties as Treasurer, the premium to be paid by the Authority.

Section 9. Officers of the Authority and members of the Commission shall receive such compensation, if any, and such per diem and mileage payments, if any, as may be fixed by the Commission with the approval of the Board.

 $\underline{\text{Section }10}.$ The Commission or any of its members may be removed from office for cause by an affirmative majority vote of the Board.

Section 11. The books and records of the Authority, the Commission and officers and agents thereof shall be open to inspection and audit by the Board at all reasonable times. The Authority shall submit an annual report to the Board.

Section 12. The Commission shall adopt and may amend bylaws and rules of procedure in accordance with the provisions of Act 31.

Section 13. The Commission may adopt a seal.

The Chairperson declared the motion carried and the resolution duly adopted.

10c) The County Board considered a request from William G. Birch, Executive Director of Community Mental Health, for a loan to cover an expected cash short fall of approximately \$150,000. Mr. Birch was present to explain the cashflow problem and answer questions. Community Mental Health must meet a payroll on December 28, 1990. Almost \$500,000.00 is owed to it by outside, but reliable sources, of which \$295,000.00 is due from the State of Michigan. These funds were already budgeted and will not be impacted by the new State administration. Administrator Aloia recommended that to be absolutely safe, the County Board approve a short term loan to Community Mental Health of \$200,000.

On a motion by Comm. DeFant, seconded by Comm. Seppanen, the County Board unanimously approved a line of credit of up to \$200,000.00 from the Budget Stabilization Fund for Community Mental Health, and further that the County charge the current rate of interest that is normal for all of its investments; however, no interest would be required of Community Mental Health if the loan is repaid within 30 days.

10k) The County Board considered a recommendation from the Committee of the Whole to implement a non-smoking policy at the Marquette County Service Center; however, a date for the beginning of the policy must be established.

On a motion by Comm. Seppanen, seconded by Comm. Arsenault, the County Board unanimously established January 1, 1991 as the effective date for the implementation of a non-smoking policy for the Marquette County Service Center.

Chairperson Corkin opened the meeting for public comment. Lynn Emerick, Director of Commission on Aging, expressed concerns over the non-smoking policy at the County Service Center, in that she has an employee who smokes in a designated smoking area, but now will have to go outside. Ms. Emerick was wondering why should the policy begin now? Why not wait until the Commission on Aging and the Cooperative Extension Service have moved to the New Office Building? Why are not all County Buildings designated as non-smoking?

The County Board responded as follows: The request came from the Health Dept. and was overwhelmingly approved by the bargaining unit to make the Service Center non-smoking, and the County Board was under the understanding that other departments in the Service Center agreed to the policy.

Wes Larson, Negaunee Township Supervisor, on behalf of the Marquette County Townships Assoc., wished the County Commissioners and Staff Happy Holidays. Mr. Larson added that Negaunee Township is trying to sell 40 acres to the County Airport. There being no further public comment, Chairperson Corkin closed this portion of the meeting.

Comm. DeFant: "Without a doubt this has been the best County Board that I have worked with, . . . its quality and leadership have led to solid accomplishments. There are no coasters among us.
