Considerable time was spent in discussing the report on "Formulating a Forest Management Study" as prepared by Mr. Spike. It was the concensus of the Commission that an up-to-date inventory providing the following information about the County Forest is needed prior to establishing By-Laws as the last inventory was compiled in 1955:

- a) Total area in Jack Pine timber as well as other species.
- b) Age class distribution of timber.
- c) Stocking of each age class.
- d) A map of the forest showing location by type, age class and stocking.

Other information that would be useful to setting policy by the Commission should include the dates and type of regeneration, method of past harvesting within the Forest and if any of the present stand is damaged from insects, ice and snow, wind, etc.

It was the conclusion of the Commission that no decisions should be made on harvesting or re-stocking until a Consulting Forester has been selected and an up-to-date inventory completed.

No public comments were offered during the second portion of the meeting allocated to public comment so the meeting was adjourned at 9:05 p.m.

On a motion by Mr. Fende, supported by Mr. Mohr and carried, the minutes of 1. the August 18, 1980 meeting were approved as mailed to each Commissioner. The cash balance of \$80,711.90 in the Forestry Fund as of October 1, 1980 was discussed. The Secretary reported that this balance includes an advance deposit of \$4,726.80 for timber stumpage received from Mead Paper and \$1,119.60 from Thilmany Pulp and Paper Company for a total of \$5,846.40. The jackpine timber for these advance deposits will be harvested during 1981. The vouchers and schedule of bills were presented and on a motion by Mr. 2. Spike, supported by Mr. Fende and carried, they were approved and the signatures of the Commission members were affixed thereto. (Schedule of bills attached.) No comments were offered during the first public comment portion of the 3. meeting. A copy of H. B. #4706 as provided by the Executive Committee of the Marquette 4. County Board of Commissioners was presented for discussion. The Forestry Commission was requested to review the proposed legislation and report back to the Executive Committee. According to a recent article appearing in The Mining Journal, the Governor has signed this bill into law, but he also indicated that the bill has technical flaws that may stall its implementation. This bill authorizes forest owners to organize forest management districts to encourage optimum use and conservation of timber resources. The bill includes incentives for long term management, provisions for linking forest improvement districts with state forest lands and encourages, through bonding, development of integrated forest industries. Inasmuch as this bill has been enacted into law, the Commission members did not take any action. The Commission does feel that there are other areas in which the Legislature could help, such as reducing the cost and abuse of workers compensation, improve marketing procedures for timber products and provide added assistance in further developing the timber industry. The Secretary reported that the County Clerk had sent a questionnaire to all 5. of Michigan's 83 counties requesting information as to whether they have an established County Forestry Commission and obtaining a copy of their by-laws. Of the 71 counties responding, only 2 (Gogebic and Ontonagon) had County Forestry - 1 -MSS176\_3\_28\_01.tif

7.

Commissions. Neither county provided a copy of their by-laws, although Gogebic County did provide a copy of Municipal Forest Act 217 of 1931, as amended, under which they operate along with a history of their operations.

Mr. Spike presented the Commission with a report he complied and entitled "Formulating a Forest Management Policy". Following a discussion on the report, it was moved by Mr. Fende, supported by Mr. Spike and carried to schedule a work session for Tuesday, December 9, 1980, at 7:00 p.m., at which time Mr. Spike's report could be discussed more fully, and the Commission could consider initial steps that should be taken towards adopting by-laws for the Forestry Commission.

6. On a motion by Mr. Fende, supported by Mr. Mohr and carried, the following dates were selected as regular meetings of the Forestry Commission during 1981:

The Sale Areas that jackpine bids were taken on this past May were also visited. A 1978 Sale Area that had good soil scarification during the harvesting operations did not show any evidence of re-generation at this time as it takes approximately 2 to 3 years before the seedlings become visible. It was the concensus of the Commission that any of type of soil scarification, whether it is achieved through the use of machinery while harvesting the trees, or disking, definitely improves the natural reforestration of jack pine.

The cash balance of \$75,857.34 in the Forestry Fund as of July 1, 1980 was discussed.

On a motion by Mr. Fende, supported by Mr. Mohr and carried, the vouchers and bills as presented were approved and the signatures of the Commission members were affixed thereto. (See attached schedule of bills).

Public notice of this special meeting was given pursuant to provisions of Act No. 267, P. A. of 1976, by having a notice posted on the Bulletin Board located in the main lobby of the Road Commission Office Building at 10:20 a.m., February 6, 1980.

The purpose of this meeting was to discuss the position of County Forester, which has been discussed by various committees of the Board of Marquette County Commissioners, and to consider any other business that may be presented.

On motion by Mr. Fende, supported by Mr. Prond and carried, the minutes of the October 29, 1979 meeting was approved as mailed to the Commission members. The cash balance of \$77,458.70 for the Forestry Fund, as of February 1, 1980, was reviewed.

The election of officers for the ensuing year was deferred until the next regular meeting of the Forestry Commission which is scheduled for May 12, 1980.

During this portion of time allocated to public comment, the Secretary informed the Commission that Mr. Clark Lebo, Consulting Forester, had a previous commitment in Rhinelander, Wisconsin and was unable to attend today's special meeting.

The Chairman addressed the Commission on a meeting he attended where the position of a County Forester was discussed. Mr. Fende pointed out that the Commission, at its meeting of March 19, 1979, took the position that the best interests of the public have been served by utilizing the services of a Registered Forester on a consulting basis, while at the same time complying with provisions of the Municipal or Community Forest Act. Following a lengthy discussion, it was moved by Mr. Prond, supported by Mr. Mohr and carried that a letter be drafted and sent to the Board of Marquette County Commissioners stating the Foresty Commission's position that they do not recommend establishing a County Forester's position for the following reasons:

- 1. The duties of a County Forester would duplicate services that are presently available through other agencies.
- 2. Only a limited number of County residents would benefit from the services of a County Forester.
- 3. The present method of utilizing a consulting Registered Forester is good and the most economical way of managing the Marquette County Forest.

- 4. There would be no additional benefits to the County Forest as a result of hiring a County Forester. The objectives in managing and maintaining the County Forest has been very adequately handled by utilizing a Forester on a consulting basis.
- 5. The uncertainty of continued funding for a full-time Forester by other agencies should be questioned.
- 6. The full-time Forester would require a four-wheel drive vehicle because of roads and trails that would have to be traveled in the County Forest and probably other areas.
- 7. Considerable additional expense would be incurred by the County in providing office space, supplies, equipment, as well as employee benefits that are not presently provided to the Consulting Forester. The benefits that may be available would not outweigh the additional expense for a full-time Forester when compared with the cost of a Consulting Forester.
- 8. Investigate the possibility of having private companies provide funds for a County Forester under a pilot program, or have their Foresters available for rendering services to County residents.

A Management Plan for the County-owned Brookridge property, prepared by Dave Otteson, of the U. S. Soil Conservation Service, was discussed. This matter was referred to the Forestry Commission as a result of a resolution adopted by the Marquette County Board of Commissioners delegating authority for County Forest management to the Forestry Commission. The Secretary was requested to advise the Board of County Commissioners that the County Forester will check the property as soon as the snow is gone, and then the Forestry Commission will submit its recommendation on the Brookridge Property Management Plan.

A letter from the Board of County Commissioners requesting information on the number of acres of County-owned forest land that requires work such as planting seedlings, pruning, etc., which could be performed by youth during the summer months was discussed. The Secretary was requested to send a copy of this letter to the County's Consulting Forester for information pertaining to the County Forest. It was pointed out that the Commission will not be able to provide this information on other County-owned lands as the County Planning Commission has not provided a copy of the County-Owned Lands Inventory as requested by the Secretary on October 1, 1979.

No additional comments were made during the second portion of the meeting allocated to public comment.

He also reported that Mead Paper has submitted a verbal proposal wherein they would be willing to plant approximately 600 jackpine seedlings per acre at a cost of \$85.00 per acre for a possible trade-off on future jackpine timber stumpage. It is estimated that there is approximately 200 acres in the County Forest that could be utilized for such type of planting. After a length discussion, it was the opinion of the Commission that the concept of such a proposal could be acceptable providing the selling of jackpine timber would not conflict with the present policy of taking bids for stumpage. The Forester indicated that he would discuss this proposal further with Mead Paper as well as contact other firms with such a proposal before any definite action is taken by the Commission.

The Forester recommended that approximately 1,600 cords of jackpine should again be harvested in 1980 as it appears that the market will be favorable.

On a motion by Mr. Nurmela, supported by Mr. Fende and carried, the following dates were selected as regular meetings of the Forestry Commission during 1980:

Proceedings of a Field Meeting of the Marquette County Forestry Commission held on July 16, 1979, at 2:00 PM.

Present: Mr. Ivan Fende, Mr. Kurt Prond and Mr. Peter Nurmela Absent: None

In Attendance: Wesley Wentela, Secretary, and Clark Lebo, County Forester.

Public notice of this meeting was given pursuant to provisions of Act No. 267, P. A. of 1976, by having a notice posted on the Bulletin Board located in the main lobby of the Road Commission Office Building at Ishpeming, Michigan.

On a motion by Mr. Prond, supported by Mr. Nurmela and carried, the Commission took official action in awarding the bids for the sale and cutting of jackpine timber in Sale Area #1-79 to Thilmany Pulp & Paper Co. and Sale Areas #2-79 and #3-79 to Mead Paper. Prior telephone approval had been granted to the Secretary on June 4, 1979 to execute a contract with Mead Paper, high bidder for Sale Areas #2-79 and #3-79, and approval had been granted on June 21, 1979 to accept the proposal of Thilmany Pulp & Paper Co. for Sale Area #1-79. The bid of Neuens Timber Products who submitted the high bid for Sale Area #1-79 was rejected because it did not meet specifications as they were unable to furnish a certificate of insurance for Workmen's Compensation. Following is a tabulation of the bids received:

The Commission began their tour by visiting the sites of Cutting Areas #2-79 and #3-79. The skidding and sawing of the jackpine trees into pulpwood lengths was observed and the Commission was well pleased with the good soil scarification that was occurring with this type of operation. It was also observed that many of the jackpine cones were beginning to open and it appears that these areas should have good natural reforestration.

Cutting operations have not been started in Sale Area #1-79. It was noted that this area had been previously harvested by the thinning method years ago and this was probably the reason that the stumpage rate was considerably less for this sale area than the other two sale areas.

Several of the cutting areas previously harvested under the strip cutting method were inspected. Natural reforestration does not appear to be as good under this type of harvesting when compared with the block type of cutting. It was the opinion of the Forester and the Commission members that some of these cutting areas should be selected for future harvesting so that the areas will have the affect of a block type cutting area which promotes a better natural reforestration because of the larger area being exposed to the sun and the soil scarification that occurs by the tree length cutting and skidding operation.

The matter of re-imbursing the County Forester for the use of his private automobile in performing forestry activities was presented. The Forester has been paid at the rate of 10¢ per mile since May 13, 1974. Since that time, the cost of operating a vehicle has nearly doubled and it was moved by Mr. Nurmela, supported by Mr. Prond and carried that the mileage rate for the County Forester be increased to 17¢ per mile.

The Forester suggested that the Commission should consider acquiring the latest aerial photos of the Marquette County Forest that are available. On a motion by Mr. Nurmela, supported by Mr. Prond and carried, the purchase of the aerial photos was approved. The Forester estimated the cost of the aerial photos to be less than \$100 and he would provide the numbers of the photos to be acquired.

On a motion by Mr. Nurmela, supported by Mr. Prond and carried, the vouchers and bills as presented were approved and the signatures of the Commission members were affixed thereto. (See attached schedule of bills).

The Secretary informed the Commission that a quit-claim deed for the undivided 1/10th interest to the N½ of the SW¼ of Section 12, T45N-R25W, Forsyth Township has been received from Mr. John E. Rahilly and recorded at the Register of Deeds Office. With this acquisition, the County of Marquette now holds the entire interest to this parcel.

Investment of moneys available in the following funds are hereby authorized to be made by the Treasurer and Governmental Support Division: Jail Bond Debt Retirement Fund, Annex Bond Debt Retirement Fund, Annex Construction Fund, Trust and Agency Fund, 100% Tax Payment Fund #1, Federal Revenue Sharing Fund, Public Improvement Fund, General Fund, All Other Funds within the Regular Bank Account, except the Airport and Forestry which are invested by the County Road Commission Additions to and/or deletions from this listing may be made with approval of the Finance Committee." past practice of investing surplus forestry funds. The Commission does not have any objection to the proposed draft investment policy as it is written at the present time.



  - Eleven (11) invitations to bid on the sale of jackpine timber on a unit price per cord basis in three (3) sale areas were mailed on May 10, 1979. These sale areas are as follows:
    - 1) Sale Area #1-79 consisting of approximately 550 cords located in the SE 1/4 of of the SE 1/4 of Section 13, T45N-R25W, Forsyth Township.
    - 2) Sale Area #2-79 consisting of approximately 600 cords located in the NE 1/4 of Section 13, T45N-R25W, Forsyth Township.
    - 3) Sale Area #3-79 consisting of approximately 400 cords located in the SE 1/4 of the NW 1/4 and the NE 1/4 of the SW 1/4 of Section 13, T45N-R25W, Forsyth Township.

On a motion by Mr. Prond, supported by Mr. Nurmela and carried, sale of the above jackpine and solicitation of bids was approved.

Proceedings of a special meeting of the Marquette County Forestry Commission held at 4:00 p.m., Monday, March 19, 1979, at the Road Commission Office, North Second Street, Ishpeming, Michigan.

Present: Mr. Peter Nurmela, Mr. Ivan Fende and Mr. Kurt Prond

Absent: None

In Attendance: Wesley Wentela, Secretary, and Clark Lebo, County Forester

Public notice of this special meeting was given pursuant to provisions of Act No. 267, P.A. of 1976, by having a notice posted on the Bulletin Board located in the main lobby of the Road Commission Office Building at 2:30 p.m., March 14, 1979.

On motion by Mr. Fende, supported by Mr. Nurmela and carried, the minutes of the October 30, 1978 and November 13, 1978 meetings were approved as mailed to the Commission members. The cash balance and interest bearing investments of the Forestry Fund as of March 1, 1979 were reviewed.

The Secretary declared that nominations for election of officers were in order and on a motion by Mr. Nurmela, supported by Mr. Prond and carried Mr. Fende was elected to serve as Chairman for the calendar year 1979. On motion by Mr. Nurmela, supported by Mr. Fende and carried, Mr. Prond was elected to serve as Vice-Chairman for the ensuing year.

No persons were present to speak during the time allocated for the first public comment portion of the meeting.

On motion by Mr. Fende, supported by Mr. Nurmela and carried, the vouchers and bills as presented were approved and the signatures of the Commission members were affixed thereto. (See attached schedule of bills).

The Secretary reviewed The Municipal or Community Forest Act--Act 217, Public Acts of 1931, that the then Board of Supervisors followed on February 18, 1948 in establishing a Forestry Commission for Marquette County. The Act states that it shall be the duty of the Forestry Commission to supervise and manage all lands of the municipality devoted to forestry and to provide for the performance of such labor therein by foresters and others as may be necessary for the proper care and maintenance of such lands as forest producing areas, to make reasonable rules and regulations concerning such lands, and to expend such moneys as may be appropriated or received for such purposes.

It has now come to the attention of the Commission that the Marquette County Soil and Water Conservation District is proposing that the County hire a County Forester. In view of the fact that the Commission does not have much information on this proposal at this time, the Secretary was directed to contact the Chairperson of the Environmental Lands and Buildings Committee and the County Controller's office on the schedule of further meetings when this subject is on the agenda for

future discussion so that the Forestry Commission may provide some input on this matter as well as be informed on the status of this proposal. The Commission is of the opinion that the best interests of the public have been served by utilizing the services of a registered forester on a consulting basis and at the same time complying with provisions of the Municipal or Community Forest Act.

The Secretary read a letter received from Mr. John E. Rahilly in response to an inquiry on the Commission's interest in acquiring the final 1/10 interest in the N½ of the SW¼ of Section 12, T45N-R25W, Forsyth Township. The County owns the remaining 9/10 interest. Mr. Rahilly advised that he is interested in selling at a reasonable price and was awaiting an offer. Following a discussion, it was moved by Mr. Nurmela, supported by Mr. Prond and carried that an offer of \$2,300 be submitted for his rights and interest to the land and timber. This offer is based on a remaining timber value of \$8,000 and a land value of \$15,000 (\$8,000 + \$15,000 =  $$23,000-\div 1/10 = $2,300).$ 

Clark Lebo, Consulting Forester, reported there has been no forestry activities during the winter months as all cutting operations in the 1978 sale areas have been completed, and the scheduling of a spring jack pine sale will be a little later than normal due to the amount of snow still in the woods and the late spring break up. Approximately 1,500 cords of jackpine will be placed on sale as previously authorized by the Commission and the timber will be clear cut in blocks not exceeding 20-acre parcels.

No persons were present for the second portion of the meeting allocated to public comment, and with no other business being presented, the meeting adjourned at 5:00 p.m.
