NOW, THEREFORE BE IT RESOLVED, that the Marquette County Board of Commissioners proposes an increase of 0.3324 mills in the operating tax millage rate to be levied in 1992.

BE IT FURTHER RESOLVED that, if adopted, the proposed additional millage will increase operating revenues from ad valorem property taxes 4.77% over such revenues generated by levies permitted without holding a hearing.

# GERALD O. CORKIN, CHAIRPERSON MARQUETTE COUNTY BOARD OF COMMISSIONERS

Chairperson Corkin opened the public hearing on Truth-in-Taxation. Dennis Aloia, County Administrator, pointed out that Marquette County is not raising the millage rates, in fact, the County's millage rate will go down because of a decrease in the Medical Care Facility debt rate. Marquette County does however receive tax dollars from the cigarette tax funds which is given to the Health Department, the liquor tax funds of which one-half is given to Substance Abuse Services, and also part of the Cobo Hall tax. The County must hold a public hearing in order to receive these tax dollars.

Chairperson Corkin opened the hearing for public comment, none was forthcoming. Chairperson Corkin closed the public hearing on Truth-in-Taxation.

# Privileged Comment

- 8a) Chairperson Corkin introduced and welcomed Mr. Gerard Markey, Marquette County's New Equalization Director.
- 8b) The County Board viewed a video presentation from Advance Michigan entitled "Vote NO, Proposals A & C." Chairperson Corkin then related that the County Board will have an in-depth discussion on Proposals A & C at the October 20, 1992 regular Board meeting.
- 8c) John Rohde, Ewing Township Supervisor, was present to discuss the fact that Ewing Township residents are not on the County's 9-1-1 System; however, are required to pay a .53 mill property tax assessment to help fund the system. Mr. Rohde explained that he will be retiring in November after 14 years as Ewing Township's Supervisor, and he wanted to take one more opportunity to come before the Board to discuss this matter. The voters in Delta County turned down a millage to support a 9-1-1 System, and it seems that they will now be funding their system through an \$18.00 start up fee and then a monthly surcharge on the telephone bills. Mr. Rohde questioned the fact that Ewing Township residents will be doubled-dipped, in that they will be paying taxes to Marquette County (which have already amounted to \$4,798.27), and will also have to pay the telephone surcharge to be put on the Delta County 9-1-1 System.

Chairperson Corkin pointed out that the County Board had the matter reviewed by Civil Counsel, and it was determined that on a County-wide millage passed by the voters, Ewing Township was not exempt. Marquette County even went the extra mile for Ewing Township and attempted to work with Delta County to contract for several services; however, Delta County officials contended that they could not provide any better services to Ewing Township than they were already receiving from Marquette County.

The County Board consensus was to request that Civil Counsel Payant reinvestigate the matter to see if there is any way to refund Ewing Township their millage dollars.

John Rohde thanked the County Board for listening to him for the last 14 years.

10b) The County Board considered a Committee of the Whole recommendation to support the Marquette County Building Authority Bond Resolution for the issuance of \$1,705,000.00 for the construction of Community Mental Health Facilities.

Comm. Potvin presented and read a list of seventeen considerations that he felt the Board should think about prior to making a decision. The main points of his presentation were: that this is a State program and the County should not have to fund it, that services to clients would be no different whether the facilities were leased or owned by Community Mental Health, and that there is a risk that the State of Michigan may not fund Community Mental Health at the level they promise to do now, especially if Proposal C passes; and that the economic development benefits would result whether the County bonded or Mental Health financed the projects on their own.

Comm. Arsenault pointed out that this bond issue will mean 60 new jobs with a 2 million dollar annual payroll, and approximately 1.2 million dollars in new construction, that is pretty good economic development with a 1.7 million dollar bond issue.

Comm. Angeli is convinced that Community Mental Health is very positive and strong in the new direction that they are going.

Comm. Seppanen reiterated that at the very beginning the County Board was aware that Mental Health could finance these projects on their own; however, it would be at a higher interest rate and therefore a greater cost to the taxpayers, with the ultimate risk still belonging to the County.

Chairperson Corkin stated that the concerns presented by Comm. Potvin have all been discussed during the past several months. Although there are no absolute guarantees, he contended that the County has the best assurances it can get, it is now the eleventh hour and time for the project to proceed.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault, and carried on a roll call vote four-to-one, with Comm. Potvin voting nay, that the County Board give approval to the Marquette County Building Authority's adoption of the Bond Resolution for the issuance of \$1,705,000.00 for Community Mental Health Facilities.

# Whetstone and Orianna Brook Drains

The County Board directs staff to bill the city and townships in an amount prorated, based on acreage in the respective districts. These units will be billed the full amount due to pay all expenses incurred in those drains. In the event that these bills are not repaid, the County may initiate legal action and by law can access costs back as necessary.

### Badger Creek Drain

It is the intention of the County to bond for the development of this drainage district in 1993. The proceeds of the bond will be used to repay all costs incurred to date and construction costs in the future. The debt on the bonds will be repaid by assessment of property owners in the district. If, for some unforeseen reason, the project does not go forward, the County will utilize the same mechanism undertaken for the Whetstone and Orianna Projects (collecting the money from the units of government).

# Employee Benefit Defici, AMCMHC

The County Board approves Mental Health's plan to appropriate \$55,000 a year out of revenues from the Community Mental Health Fund for approximately five years, to fully fund vacation and sick leave benefits.

10f) The County Board considered a recommendation from the Committee of the Whole to submit three projects; Acocks site, general improvements at Perkins Park, and the Courthouse parking ramp, to the: "Rebuild Michigan Initiative Grant Program." Dennis Aloia, County Administrator, added that the County will offer Acocks for sale on bids one more time before it takes the final steps for its demolition. The County should know whether or not it receives the grant by December.

It was moved by Comm. Potvin, seconded by Comm. Arsenault, and

unanimously carried to approve the recommendation to submit the projects.

10i) The County Board considered a recommendation from the Committee of the Whole to organize a picnic for members of various County Boards and Commissions.

It was moved by Comm. Potvin, seconded by Comm. Angeli, and unanimously carried that the recommendation be referred to Civil Counsel for further review.

10j) The County Board considered a communication from the Marquette County Solid Waste Management Authority. Its Board of Trustees will be conducting a search for an Executive Director, and Article 2.1(a) and Article 2.3 of the Intergovernmental Agreement speak to the role of the director. The Authority is requesting that each participating municipality approve a few appropriate options that will give the Authority latitude to continue to run the landfill in an efficient manner. The options that will be pursued include: 1) recruit a non-degreed individual with appropriate qualifications; 2) recruit a interim non-degreed individual with appropriate qualifications to supervise the landfill operation during the search for a new director; and 3) hire a professional contracted landfill management firm with appropriate qualifications.

Jim Kippola, Senior Planner, was present and had reviewed the memo from the Solid Waste Authority, and expressed the following concerns: That the

three options outlined are too vague to be able to discuss how they may or may not effect the carrying out of the Authority's implementation of the Solid Waste Program. That items #1) and #2) state "appropriate qualifications" What are the qualifications? Do they include some emphasis on recycling as is mandated in the Solid Waste Plan? Also the contracting of landfill operations and needs more definition. A sample contract would help because contracting alone does not increase efficiency in and by itself.

Civil Counsel, David Payant, further pointed out that a three-quarter vote of the participating municipalities (of which Marquette County is one), is required to amend the Interlocal Agreement.

Commissioners agreed that more information is necessary before responding to the Authority's survey. It was moved by Comm. Arsenault, seconded by Comm. Angeli, and unanimously carried that the County Board send a letter to the Authority and request answers to Mr. Kippola's questions.

It was further moved by Comm. Seppanen, seconded by Comm. Potvin, and carried on a roll call vote three-to-two, with Comm. Corkin and Comm. Arsenault voting nay, that the County offer the Authority the assistance of the Human Resource Director, if needed, to assist in drafting a job description for the Solid Waste Management Authority Director.

Chairperson Corkin opened the meeting for public comment, none was forthcoming.

### Commissioner Comment

Comm. Potvin pointed out that the County Board Airport's plan for a \$3.00 passenger boarding fee was approved by the FAA, which will mean approximately \$459,700.00 per year in revenue for runway expansion and deer fencing.

Comm. Potvin also pointed out that the MUSTFA cleanup appeal was won by the Airport and it will get the funding it needs. This is good news in light of the fact that MUSTFA funds may be running low and discontinued in the future.

Comm. Potvin also announced (as per his request and Chairperson Corkin's recommendation) that the DNR has requested him to serve on a 20-member Little Presque Isle Planning Committee.

It was moved by Comm. Seppanen, seconded by Comm. Arsenault, and unanimously carried that the County Board go into Closed Session to discuss pending litigation.

Chairperson Corkin declared a brief recess in order to clear Commission Chambers.
