To the Honorable Board of Supervisors, Marquette County, Michigan.

Gentlemen: Your Poor Contact Committee by call of the Chairman, William J. Wiseman, held a meeting September 21st in Wells Township to investigate certain charges made by Supervisor Patient to the effect that unfairness is frequent with the distribution of relief in that Township by the Poor Commission, and especially in the case of Grant VanGilders.

In company with Mr. Patient we called at Mr. VanGilders' house. We found him at home and doing a well man's work wheeling wood. His home is a comfortable log house. He said that he was feeling quite well and had registered for work. He has lived there for at least fifteen years and has only one acre cleared and only one fourth of that under cultivation. He claimed his property is worth \$600.00; is mortgaged for \$200.00; is assessed for \$50.00. He is a bachelor.

Mr. Patient introduced Mr. Louis Gelman. Gelman lives on 40 acres which is mortgaged for \$100.00. He is able to work but is afraid to leave his house for fear it will burn down during his absence. Gelman is a Russian Pole and his family is in Europe. Is willing to transfer his property to the authorities.

Mr. Patient introduced Mr. John Peer. His complaint was that he was charged with orders that he never received, as follows: August, 1933-\$5.00; September, 1933--\$5.00; October, 1933-\$5.00; October, 1933- \$10.00; November, 1933 - \$5.00; December, 1933-\$5.00. Investigation showed that three of these orders had been cashed by him at the Watson store, and the others were canceled because he was working.

Contrary to expectation, we found good roads all the way.

On call of the Chairman, the Committee met in the office of E. R. Nelson for further investigation of the Wells Township matter. We found confirmation of all the statements noted above, also that some of the confusion or misunderstanding in the John Peer matter may have been partly the fault of Mr. Nelson in failing to notify the Supervisor, or Mr. Peer, of the canceling of the orders on account of his getting employment and not being entitled to relief. Mr. Nelson and his clerks will be careful about this matter in future. Also poor relief at the time of the misunderstanding with Mr. Peer became partly a matter for the Marquette County Michigan Emergency Relief Commission, and our investigation did not take us into that organization's books.

✓ A petition to the Marquette County Road Commission to keep road open to the Vercellino Farm for wheel traffic during the winter months, signed by Ernest Keskimaki and 35 others from Negaunee City and Forsyth Township, was read, and upon motion of Supervisor Nightingale, supported by Supervisor Frei, was referred to the Committee on Highways and Bridges and the County Road Commission.

✓ A petition from the residents of Chocolay Township for snow plowing service from Mangum school corners South 3/4 mile to corner, from Mangum school corners North 1/2 mile to end of road, from County Road No. 480 North 1/2 mile to Nelson Farm, Mattson road from Airport on M.28 to Gerloch Farm 1/2 mile and from end of Concrete M.28 at Green Garden East 1/2 mile to Robert Zerbel Farm; signed by Lester G. The motion was seconded by Supervisor McNamara and carried.

✓ A communication relative to a co-operative Peninsula-wide campaign to bring new tourist dollars to our peninsula was read and it was moved by Supervisor Nicholas that as an appropriation had already been made to the Upper Peninsula Development Bureau for this purpose, that the communication be ordered filed. Motion was seconded by Supervisor Anderson and carried.

✓ A communication from the Department of Aeronautics urging that a letter be forwarded to Hon. Clark Howell, Chairman of the President's Aviation Commission, Washington, D.C., urging that a permanent Federal Aeronautics Commission be created at once to take over all governmental functions pertaining to civil aeronautics, together with a letter from Supervisor Nicholas, favoring the request, was read.

✓ Supervisor Nicholas stated that as the letter from the Aviation Committee was addressed to the Clerk that he would move that he be authorized to write the letter as requested by the Secretary of the Joint Aviation Coordinating Committee. Motion was supported by Supervisor Stakel and carried.

✓ The Chair reported that at the last meeting of this Board he was directed to name a committee on the proposed Michigan Centennial Celebration for 1935 and 1936. He stated that he would appoint as the representatives from this Board, Supervisors Stakel and Nicholas, to act with Mr. L. A. Chase and Mr. Ray Brotherton, appointed by the Marquette County Historical Society as members of this Committee.

✓ The following communication and resolution was read. After remarks by K. I. Sawyer, Superintendent of the County Road Commission, it was moved by Supervisor Nicholas that the communication be filed and that the resolution be adopted. Motion was supported by Supervisor Frei and carried.

Dear Sir:- I am enclosing a copy of the resolutions adopted at the meeting held in Crystal Falls, last Wednesday for the purpose of promoting a proposed road program through the Upper Peninsula by using as much Federal Emergency money as possible in conjunction with regular State Highway money.

The resolutions, you will note, call for the formation of a permanent committee consisting of the Chairman of the Board of Supervisors in each county, or his appointee, together with an ex-officio member who is the Upper Peninsula member of the State Planning Commission.

We note from the press that the Governor is abolishing the State Planning Commission so that the committee will now consist of the fifteen members, one from each county, above described.

The members of the Boards of Supervisors who were present at this meeting Wednesday met the same day and mutually agreed that the permanent committee, of which you are a member, should meet at Marquette on February 20th at the Northland Hotel at 11:00 a.m. This date was selected in that it would permit the Board of Supervisors in each county to meet in the meantime and to confirm their chairman for this appointment and also, to endorse the resolutions, a copy of which is enclosed, so as to give the permanent committee the official sanction of the governing board of each county.

You will, therefore, please submit the resolutions enclosed to your Board at this meeting for their endorsement and will you also please arrange to be present at Marquette on February 20th at 11:00 a.m., or in the event that you cannot will you please select your appointee to serve on this committee?

Please reply at your earliest convenience so that we can make our plans accordingly. We believe that it is very essential that all Chairmen give their hearty support to this very important movement which will allow us to possibly accomplish in one or two years, hard surfacing of our trunk lines which may otherwise never be accomplished.

WHEREAS, the Upper Peninsula of Michigan finds it necessary to develop its natural resources in climate, scenery, game and fishing to the end of making this section of the State a recreation center, and,

WHEREAS, we are handicapped in bringing about this objective because of the unimproved condition of our main highways that form connecting links and through routes serving all parts of the Peninsula.

THEREFORE, BE IT RESOLVED, that it is the sense of this meeting, composed of representative groups from all counties of the Upper Peninsula, that the best possible major project of a permanent value for the Upper Peninsula as a unit carrying out the principles emphasized in President Roosevelt's recent message, is the building of continuous hard surfaced roads.

BE IT FURTHER RESOLVED, in accordance with the above principle that it is the sense of this meeting that construction of hard surfaced roads on trunk line routes should be conducted under the direct supervision and planning of the State Highway Department in co-operation with Emergency Relief Administration or its successor.

BE IT FURTHER RESOLVED, that as large a proportion as possible of Federal monies designated for unemployment is hereby requested for use in conjunction with the regular highway monies allocated for such purpose.

THEREFORE, we recommend that a permanent committee be established consisting of the Chairman of the Board of Supervisors or his appointee from each county.

WE FURTHER RECOMMEND, that this committee immediately proceed to function in enlisting the entire support of their respective counties to this program and to contact their members of the Legislature and members of Congress.

FURTHER, that this committee is requested to immediately meet and organize and proceed to present and promote this program through our Governor, our State Departments and through the proper Federal channels.

Gentlemen:-In the matter of the recommendation of the County Tax Commission, that all remaining roads, streets and alleys, to be taken over by the County Road Commission under the McNitt Law, be adopted forthwith by the County Road Commission, such recommendation having been heretofore presented to your Board, and referred for consideration.

The findings and action of such joint body are, to-wit:

It appears that to grant the request will seriously embarrass the Road Commission in that it will again largely increase the requirements placed on the Board, and in the face of decreased sources of money to carry on their work, and that if so required it must be anticipated that some of these roads will not be rebuilt to standard condition suitable for maintenance until finances therefor are available, and that the equipment and funds available to the Commission are such that the more unimportant of these roads may have to wait at times for maintenance service, and that for the time being it will not be possible to include all of these roads in the snow plow schedule.

It appears that to deny this request will put all but one of the Townships to very serious embarrassment. That all but one Township will have a deficit in its financial condition for this year. That if the Townships can be relieved of all road expense it may be anticipated that the Townships may be operated from anticipated revenues. That notwithstanding the fact that the County Road Commission will be overloaded in proportion to their plant and finances, it may be anticipated that equal or better service will be given in most instances on the roads by the County Road Commission than can be financed by the Townships, and at a considerably less cost to the County as a whole, therefore

BE IT RESOLVED, by the County Tax Commission, the Committee on County Roads and Bridges, and the Budget Committee, of the Board of Supervisors, and the Board of County Road Commissioners, all of the County of Marquette, sitting in joint meeting.

Gentlemen:--At a joint meeting of the County Tax Commission, the Budget Committee, and the Road and Bridge Committee, of the Board of Supervisors, and the County Road Commission, all of Marquette County, Michigan, held with reference to adoption of County Roads on January 14th, 1935, discussion was had of many phases of this matter.

Suggestions tending to economic public administration with limitation on possible gross costs of public service were advanced, and on motion, the Road Commission was directed to address this communication to the Board.

There are now in the County a considerable number of persons living on outlying or isolated tracts of land. To provide roads, schools, and other public services for these people, in many instances, requires expenditure of public funds out of proportion to the economic return to the County accruing from the production, and the residency of these people on these lands. Many of them are on lands acquired by homestead, or at nominal cost, and are of sub marginal character. Many of the residents are consequently receiving relief at public expense, and it is deemed improbable that many of these will ever be on a self supporting basis if they remain on these lands.

At the present time the Road Commission is supplying snow plow service on 591 miles of road, or approximately a twenty-five per cent overload for the available equipment, and necessitating delayed service to a portion of the county at all times. Data in the road office indicates that this plow service would need to be extended 114 additional miles, to give service to the known residents in the various parts of the county, on side or lateral roads who may now properly request this service. Most of this additional mileage of road will have to be rebuilt before maintenance service can be supplied at reasonable cost. A considerable percentage of the territory traversed by such roads is not properly agricultural and it is probable that such public services are not economically justified.

The tendency for persons to move onto these isolated and sub-marginal lands, which may be acquired at slight expense, continues, and requests for expenditure of public funds to accommodate those moving on these lands are very frequent. These usually ultimately result in costs for roads, increased cost for schools, account of transportation, and costs for relief.

Marquette County has a large land area which may be acquired at small expense, and which constitutes a potential source for large uneconomic expenditure of public funds for public services, which may under existing laws and conditions be equitably requested by persons moving onto these lands. There are also very considerable areas of good lands where settlement might profitably be encouraged, and where public services can be supplied with economic justification.

It would appear that Marquette County might properly be divided into areas or zones, in which the County would supply all the public services expected at public expense, other areas or zones where certain, or limited services would be supplied, and still others where no public moneys would be expended, and that determination of such areas could be official, published, and settlement of improper areas stopped at the present point, and thereby limit the potential demand on public funds to projects which are economically justifiable.

It is recommended that a committee be formed to study all matters pertaining to these suggestions, to investigate existing legislation pertaining to the same, to recommend needed legislation to make some such plan effective, and to make specific recommendations to the Marquette County Board of Supervisors in the matter.

Sirs:--Relative to disposition of money received on account of motor vehicle license taxes and gasoline taxes returnable to this county for the calendar year 1935, and in conformity to Public Acts of Michigan numbers 7 and 8 of the Extra Session of 1934, your Board of County Road Commissioners recommend:

Pursuant to such acts, one half of each settlement on account of the above mentioned monies, is to be credited to the County Road Fund to be used for administration, maintenance, betterments, and construction of County Roads.

Further, pursuant to such acts, that the remainder, hereinafter called the second half of such monies, as returned to Marquette County shall be applied as follows and in the following order of priority:

First priority second half -- The sum of \$37,153.14 shall be credited to the Highway Bond Retirement Fund to pay principal, interest, and disbursing fees on the General County Highway Bonds for payments due thereon, to and inclusive of the interest payments payable in April 1936, which interest payment comes due prior to anticipated receipts on monies from these sources for the year 1936.

Second priority second half -- The difference between the second half of such above mentioned monies and the amount of money to be credited to the Highway Bond Retirement Fund is then to be divided and applied as follows:

(a) One half of the difference mentioned in second priority second half, immediately above, is to be credited to the County Road Fund and used for maintenance of County Roads adopted in conformity to Act 130 P.A. Michigan 1931.

(b) The remaining half of second priority second half, as mentioned immediately above, shall be divided as follows:

Gentlemen:-- Your committee to whom was referred matters pertaining to zoning Marquette County; report the following progress and make the following recommendations as being in order at this time:

Communication has been had with the Attorney General's Department, with Wisconsin officials, members of other counties interested in this subject, and some general review has been carried on.

It appears that the need to limit land and building use, to the end that the public welfare be protected, and abnormal taxation prevented by denying the extension of publicly financed services under uneconomic conditions, is becoming generally recognized.

Wisconsin is now practicing the limitation of land and building use under a zoning law which has been adopted by several counties. All reports from Wisconsin show the desirability of this move.

The report from the Attorney General indicates that enabling legislation is required before successful progress can be made in such a program.

There are two bills before the Legislature at the present time. No copies of these have yet been received.

We recommend, that your committee be authorized to send communication to the members of the State Legislature urging passage of legislation permitting the limitation of land and building use, similar in character to the system now practiced in Wisconsin, and to send communication to the counties of the Upper Peninsula of Michigan and of the Northern part of the Southern Peninsula, explaining the move being taken by this county and urging their earnest consideration.

We recommend continuation of a committee on this subject.

Gentlemen:-- Your Committee on Buildings, Grounds and Insurance made their final inspection for the year on August 15th and 16th, 1934. They were accompanied on this inspection by K. I. Sawyer, Superintendent of the County Road Commission, Frank L. Denny, Deputy County Treasurer and Bernard York of the North Michigan Insurance Agency. Messrs. Denny and York were invited to attend this inspection so that they might gather information relative to the situation and construction of the County buildings for the purpose of formulating reports in compliance with recommendations made by your Insurance Committee. We first visited the County Road properties at Ishpeming and then motored to Champion Beach. After lunch we motored to Morgan Heights. The following day we visited the Fair Grounds, Court House and Jail and finally the Infirmary where the party was served dinner by Mr. and Mrs. Leonard Morrison, caretakers. We found all of the buildings and grounds in first-class shape, with the exception of the Morgan Heights grounds, which were undergoing improvements. We were assured by the Trustees that these grounds would also be put in first-class condition, in keeping with the rest of the County properties.

We find that there are two bills now in the Legislature which will make it possible to secure the needed control.

The committee is urging favorable consideration of these bills. A copy of our letter is attached.

We urge to canvass your own problem. If you find yourselves in a similar situation to ours, please join us in urging this move on the Legislature.

To the Governor and Members of the State Legislature.

Sirs: Marquette County has large areas not suited for agriculture, and other areas which may properly be utilized for agriculture.

The present economic condition has created a tendency for persons to move onto lands unsuited for use and may of them isolated and remote from existing settlement which may be had at very little first cost. This is creating a need for roads and schools at public expense and in many instances an early demand for relief.

To pay for such services is uneconomic and under the present statutes impossible, and to pay for the same is not in the interest of the public welfare.

There are two bills, namely, House Bill 302, introduced by Representative O'Dell and Nichols and Senate Bill Number 248, introduced by Senator Luecke, which apparently will give the needed control and ultimate relief in the public interest.

The problem is so acute in this county that the Board of Supervisors has appointed this special committee to help in any way possible to accomplish the needed control and the resultant relief from uneconomic expenditure of public funds.

We urge favorable consideration of the above mentioned bills.

For your information I will remind you that a bond issue of \$130,000.00 for the construction of this building was authorized at the April election in 1929 and bonds were issued to that amount, and by resolution of this Board ordered sold, as money was needed in order to save accrued interest. This County sold \$100,000.00 worth of bonds. During the planning and construction of this building bills were paid, for architect's fees and other expenses, to the amount of \$26,138.52 from the General Fund of the County.

The remaining \$30,000.00 worth of bonds is still in the hands of the County. These are long term bonds running to January 1942 and if they had been sold when the bond issue was put on sale would have cost the County \$18,585.13 in interest to maturity, which the Board of Supervisors and County Officers considered worth saving. This \$26,138.52 is standing as a charge against the Children's Unit and should be cancelled by resolution of the Board, and I respectfully request that you refer this matter to the proper committee in order to have this matter taken care of before the next audit is made.

Franson, Sheriff, that the present rate of 45 cents per day for feeding prisoners be raised, beg to report that after considering the matter thoroughly, taking into account the rise in the price of foodstuffs, and also taking into account the rates paid the sheriffs in other counties in Northern Michigan, respectfully recommend to the Board that the rate be raised from 45 cents to 50 cents per day for the balance of the present fiscal year.

To the Honorable Board of Supervisors:

The agricultural committee met in the county agricultural agent's office on Monday, May 6, to discuss the problem of grasshopper eradication.

The federal government has promised to give the county 124 tons of bran and enough calcium arsenate to make up 248 tons of poison bait providing the county buys the molasses, banana oil and salt. This is five times as much poison as used in 1934. The federal government claims this is the last year for free bran and poison and hopes the county will make a clean-up this year.

The committee believes \$1,000, which has been appropriated, will take care of the cost of molasses, banana oil and salt, but will not allow for unloading, storage, nor distribution of poison material, nor will it pay for supervision or distribution of poison bait on State and company cut over land.

We would like to ask the County Road Commission to distribute the material for making bait, as they have done in previous years. We are asking each supervisor to supervise the work in his township. We will undoubtedly need added money to pay for mixing bait and spreading on cut over land not owned by farmers. We may need an additional \$500, but will not spend it unless absolutely needed. Therefore, we ask for an additional \$500 from the General Fund to be used if needed in grasshopper eradication work.

Your Budget and Executive Committee to whom was referred the question of studying the necessity and desirability of appointing an Assistant Prosecuting Attorney, beg to advise that the Committee spent considerable time with the Prosecuting Attorney on July 15th, at which meeting he submitted a very complete report outlining the situation. After considerable discussion, however, the committee decided that this question was of such importance that they beg to ask the Board for an extension of time before making a definite decision.

The Committee also took up the matter of the unsold Morgan Heights Children's Unit bonds referred to it for consideration, and we respectfully offer the following resolution and move its adoption.

"WHEREAS, the Board of Supervisors of this County at a meeting held on the 22nd day of May, 1929, duly authorized and directed the execution and sale of its negotiable bonds to the amount of \$130,000.00, the proceeds thereof to be used in the construction of the Children's Unit at Morgan Heights in this County, and

WHEREAS, the total amount of bonds so authorized was duly executed, but bonds to the amount of only \$100,000 were sold and delivered, the balance of \$30,000 still being in the hands of the Treasurer of this County, and

WHEREAS, there was required for the completion of said Unit, over and above the amount realized from the bonds so sold, the sum of \$26,138.52, which sum was paid out of the General Funds of this County, and

WHEREAS, the withholding from sale of said \$30,000.00 of bonds will mean a saving to the taxpayers of this county of \$18,585.13 in interest to the maturity thereof; and

WHEREAS, the purpose for which all of said bonds were so authorized to be sold has been fully met and it is now deemed advisable that the bonds on hand as aforesaid, and which are negotiable, by delivery, be cancelled:

NOW THEREFORE, BE IT RESOLVED AND ORDERED that the payment of said sum of \$26,138.52 out of the General Funds of this County be and the same is hereby in all respects ratified and approved and that the charge of that amount against the said Children's Unit as the same appears on the books and records of the Treasurer of this County be cancelled by appropriate bookkeeping entries. And BE IT FURTHER RESOLVED AND ORDERED that the bonds in the amount of \$30,000.00 in the hands of the Treasurer as aforesaid, be cancelled by said Treasurer in the presence of the Chairman of this Board and of the County Clerk by mutilation or otherwise and in such manner as to render subsequent negotiation thereof impossible."

Your Committee also recommends that in spite of the fact that the entire Board generously has allowed the Committee to incur an expenditure of \$250.00 in emergencies, nevertheless that all such matters that require an expenditure of money, particularly those pertaining to county officers' expenses to attend meetings or conventions, that all these communications be referred to the entire Board for consideration.

Your Committee also recommends to the Board that the County purchase the necessary paint for re-painting the walls and floors of the County Jail where that particular work was deemed necessary after an inspection by the Sheriff and the Chairman of this Committee. It is understood that all of the labor will be provided by the E.R.A. without cost to the County. Estimated cost, \$77.50.

✓ The following report of the Morgan Heights Sanatorium Contact Committee was read, and it was moved by Supervisor Dolf that the report be adopted. Seconded by Supervisor Ghiardi and carried.

REPORT OF CONTACT COMMITTEE.

Mr. Chairman:--Upon the invitation of the Board of Trustees of Morgan Heights Sanatorium, your contact committee attended a special meeting of the board at the Sanatorium at five P.M., July 17th.

Mr. Collins, chairman of the board, said that the object of the meeting was to inform the Board of Supervisors through your contact committee as to the progress that has been made within the last year in improvements within the several buildings and about the grounds.

The main floor of the adult building has been covered with a very fine grade of linoleum of a plain brown color. This was done with the idea of making a more sanitary floor condition. The original floor being of hardwood it was in a more or less worn condition.

A number of the rooms and halls which were in need of paint have been taken care of in this respect with a very pleasing combination of colors.

Another improvement made within the last year was the widening of the doorways in three of the patient rooms in the adult building.

It was discovered sometime ago that the three doorways mentioned were more narrow than the others and would not permit of the moving of cots or beds through them. In order to move the cots or beds they would have to be taken apart. This change means much in the matter of moving patients into or out of the rooms.

The trustees said that one of the outstanding problems that confronted them upon their taking over the trusteeship was the matter of fire protection. As most of the members of your board know, several of the buildings are of non-fireproof construction.

Your contact committee feels that this matter has been taken care of in a most commendable way. At about the center of the grounds is a hydrant which takes a two inch hose. There are four hundred feet of the 2" hose which will reach to the farthest corner of any of the buildings. The power for the pump which is located in an underground room is furnished by a gasoline engine, which is tested daily. Water is pumped from a well which will furnish an adequate supply. We were given a demonstration to show that the apparatus will throw a stream over any of the buildings and this can be done in a very few minutes.

In addition to this so called auxiliary there is a standard size hydrant within a few feet of the 2 inch one. This hydrant is supplied with water from Morgan creek, which runs close to highway M 28, in front of the sanatorium property. Within a few feet of the creek, which carries a very substantial flow of water, is a sump which is a box-like structure built of logs and covered with planking. There is a door in the covering to allow the hose to be put into the water.

The sump is seven feet square with a depth of seven feet of water and is directly connected with the creek, assuring a continuous supply of water.

A standard size pipe runs from the sump underground at an average depth of four feet, connecting with the hydrant on the grounds.

The arrangement has been made whereby in case of fire, the Negaunee or Ishpeming fire department would be called and their pumping engine brought to the sump and connected up with the pipe leading to the hydrant on the grounds. The trustees are assured that within twenty minutes of the time that the department would be called they would have water playing on the fire with this apparatus. In the meantime, while getting this main service working, the auxiliary two inch hose would be giving service.

A one and one-half inch fire hose has been installed in the nurses' quarters, also in the doctor's home.

The roof of the boiler house is in need of repair, it being in a leaky condition. The outside of the building has a shabby appearance and does not harmonize with the surrounding property. The trustees have given this consideration and hope to have some much needed changes made as soon as same can be taken care of.

To the South of the main buildings the underbrush has been removed back for a distance of probably two hundred feet. This has improved the appearance of the tree growth in that vicinity. The grounds on the North side have been cleared of several coops and sheds and look much better than before this was done.

In the basement where the steel ceiling was exposed, this has been plastered to conform with the fire underwriters' requirements.

A room in the basement has been equipped for the purpose of a mortuary and for conducting post mortem examinations. The trustees informed your committee that this

is one of the requirements in being on the accredited list of sanatoriums.

The labor cost connected with the work that has been done, with the exception of supervision, was taken care of through F.E.R.A.

There are other items of work in connection with the improvement of the grounds which the trustees are desirous of accomplishing. One is further removal of underbrush, and also the construction of a suitable archway at the entrance to the grounds from highway M 28.

At the conclusion of the meeting your committee and the trustees were served a very delightful supper.

It is the opinion of your committee that much has been accomplished in the way of improvements within the sanatorium and about the grounds.

Gentlemen:

During the winter, your Board had a special committee appointed for the purpose of studying the effecting of a control on land use, with the expected end of control upon the demands on the public treasury for public services.

This committee did excellent work in the promoting of enabling legislation to permit the necessary acts by your Board tending towards the control of land use. We believe such legislation to be now in effect.

Applications are received at nearly every meeting of the Road Commission for new roads or road development leading to properties bought in good faith by persons who will need these public services to utilize their properties. Many of these have to be denied for the present, because of lack of funds and there is created great inconvenience to the owners. Some of these improvements probably will ultimately be made and result in expenditure of public funds for works not economically justified but required for social and health reasons.

We recommend that the matter of regulating land use, or zoning, be again considered to the end that persons buying property will then have an official source of information as to services which may be expected and control may be had on the prospective demands for services at public expense.

The above mentioned communication was received by your Board, referred by you to the County Road and Bridge Committee and the Board of County Road Commissioners, and at a joint meeting of these bodies the writer was directed to address this letter to this Board.

The above communication states Mr. Petersen had made inquiry and was unable to secure a satisfactory reply. There is no inquiry concerning this matter from Mr. Petersen in the files of the Road Commission and no record or knowledge in the headquarters office of such inquiry. When made, the inquiry referred to must have been directed to some of the field staff not informed on the subject matter involved.

The road probably referred to is County Road 553, extending from the County Infirmary in Marquette City southerly through Sands to Little Lake, in as near as possible an air line which will give Marquette City connection, seventeen miles in length, to Little Lake and thence via M-35 to Escanaba, as well as serving Sands Township with a main highway. This road in no way conflicts with or replaces County Road EL, which runs between Gwinn and County Road 553 in the vicinity of Plains crossing, and which is the line of traffic between Sands and Gwinn. These two roads are for entirely different flows of traffic and not in conflict, so far as we can see, and the only possible question involved is as to priority of improvement.

The traffic involved on the questioned route now flows Little Lake via Carlshend to Marquette and traffic via Gwinn now flows over M-35, a hard surfaced road.

Gentlemen:--On August 7th, 1935 Mr. Ben Sparks, District Engineer for the State Highway Department, called on Mr. P. B. Spear, Chairman of the Board of County Road Commissioners, with reference to the matter of the County financing the securing of rights of way on trunk line highways for the State of Michigan.

Mr. Sparks left with Mr. Spear two resolutions, copies of which are attached. He further gave Mr. Spear the impression that if Marquette County did not secure these rights of way for the State Highway Department, it was to be expected that the State Highway Department would not put on or prosecute road improvement work in the County.

Conference was had relative to this matter on several occasions, between the Commissioners and other interested citizens and with members of the Board of Supervisors.

These appear to be the conditions.

That the resolutions as tendered by Mr. Sparks cannot be signed for the reason that they pledge the gasoline and weight tax monies which are already allocated to certain definite purposes, including the payment of principal and interest on bonds.

That the resources of the County Road Commission would not permit the purchase of these rights of way from County Road Funds because of the large obligation now placed on the County Road Commission through the handling of the McNitt Roads, the adoption of which has been consummated in advance of the State requirements at the request of your Board, and because of the fact that the County Road Commission is anticipating co-operation with the Works Progress Administration on behalf of County Roads.

It appears that there is a vital question in the interest of the County involved, there is the matter of policy as to whether the assistance requested should be granted the State Highway Department, and if so granted, there is the matter of procedure by which it should be granted.

It is the feeling of the Board of County Road Commissioners that these are matters entirely within the jurisdiction of the Board of Supervisors, and this communication is addressed to you to call the matter to your attention, and to emphasize the importance of early action thereon.

It is the opinion of the Board of County Road Commissioners that Marquette County should assist the State Highway Department in securing these rights of way.

That the sum of not to exceed Twelve Thousand Dollars be appropriated from monies not otherwise appropriated to be paid by the County Clerk to the State Highway Department of Michigan in such amounts and for such purposes and under such conditions as are hereinafter set forth, to-wit:-

Not to exceed Four Thousand Dollars or such portion thereof as is necessary to pay for the actual cost of securing the rights of way for constructing the so-called relocation of U.S. 41-M 28 Negaunee to Ishpeming, said sum to be due and payable at such time as all rights of way required have been secured and the contracts for grading and all structures between Second Street in Ishpeming and the proposed new junction with the present U.S. 41 near the North Lake Forks has been executed; and proof thereof has been furnished to said Clerk by suitable certificate; and

Not to exceed Four Thousand Dollars or such portion thereof as is necessary to pay for the actual cost of securing the rights of way for the relocation and construction of grade and drainage structures on U.S. 41 from the end of the concrete South of Skandia to the Marquette-Alger County Line, such sum to be due and payable at such time as all rights of way have been secured and the contracts for grading and drainage structures have been executed for this work and proof thereof has been furnished to said Clerk by suitable certificates; and

Not to exceed Two Thousand Dollars or such portion thereof as is necessary to pay for the actual cost of securing the rights of way for the reconstruction of grade and drainage structures on M 95 between Republic and U.S. 41-M 28, such sum to be due and payable at such times as all rights of way for the entire road have been secured and contracts for grading and drainage structures for at least one half of the above mentioned portion of M 95 have been executed and proof thereof has been furnished to said Clerk by suitable certificates; and

Not to exceed Two Thousand Dollars or such portion thereof as is necessary to pay for the actual cost of securing the rights of way for the grading and drainage structures on the extension of M 94 from the Alger County Line Westerly to U.S. 41-M 28 in the vicinity of Harvey, such sum to be due and payable at such time as all rights of way for this entire road have been secured and contracts for a bridge over the Choccolay River and for grading and drainage structures on at least one half the length of this road, including the crossing with the Choccolay River, have been executed, and proof thereof has been furnished to said Clerk by suitable certificates.

AND BE IT FURTHER RESOLVED, that this aid is offered as inducement for early action and that this offer is limited and expires in one year from date of passage of this resolution and the Clerk is hereby directed to not make any payment hereunder after one year has elapsed.

AND FURTHER BE IT RESOLVED, that the jobs are listed above as to priority in the order of their importance to Marquette County and this Board recommends and urges on the Honorable Murray D. Van Wagoner that they be pressed and prosecuted in such order of priority.

It was moved by Supervisor Nicholas that this resolution be referred to the Prosecuting Attorney for his approval as to form. Supported by Supervisor Stakel and carried.

The report of The Travelers Insurance Co., stating that the two Automatic Push Button Passenger Elevators located at Morgan Heights Sanitarium were inspected on July 22, 1935 and found to be in good operating condition, was read and ordered filed by the Chairman.

The report of the Auditing Committee was read, and upon motion of Supervisor Nightingale, supported by Supervisor St. Onge, adopted by the following Yea and Nay vote:

The motion was supported by Supervisor Wiseman and unanimously carried.

✓ It was moved by Supervisor Dobson that the Clerk request the Poor Commission when sending in their monthly report to itemize their miscellaneous account. Supported by Supervisor Nicholas and unanimously carried.

✓ The following report of the Committee on Highways and Bridges and the County Road Commission was read. Upon motion of Supervisor Wiseman, supported by Supervisor Nardi, the report was unanimously adopted.

Gentlemen:- In the matter of various petitions and communications referred to the Committee on County Roads and Bridges and the Board of County Road Commissioners.

Your Committee, with the County Road Commission, met on July 25, 1935 and viewed the sites of various roads in Humboldt Township and also met in business session and heard Mr. B.B. Balkema, Project Engineer, for the Works Progress Administration in this territory, and considered at length a proposition of applying to the Works Progress Administration for a large project for improvement to, farm to market, or secondary roads now in the County Road System.

The County Road Commission at this meeting decided to apply for this project and the Committee concurred in the action taken.

The Committee again met on August 21, 1935 and viewed the sites referred to in petitions in Forsyth, Chocoley and Sands Townships and then met in business session.

We report that the application to the Works Progress Administration as made by the Board of County Road Commissioners above mentioned, includes a large number of projects scattered in all parts of the County and contemplates the improvement of these roads with labor to be furnished by the Federal Government under the Works Progress Administration, with the Board of County Road Commissioners acting as sponsor of the project, contributing their own services, and equipment, and with the Federal Government contributing some materials, and supplies, and equipment. The project is well planned to meet the relief labor needs of the County and to furnish much needed road improvements scattered throughout the County which would not be otherwise available or possible of construction from present County finances.

Relative to petition from James Torreano and others pertaining to construction of the Big and Little Shag Lake Roads.

The improvement mentioned in this petition is included in the application to the Works Progress Administration and this appears to be the only way to handle the job at this time. It is hoped and expected that these roads will be improved under the project.

Relative to petition from Matt Mackey and others relative to work in Humboldt Township.

We find that the Hinsula and Luoma Roads are included for reconstruction and that the bridge at Mustamaa's is also included in the above mentioned application, and it is also hoped and expected that this work will be undertaken under the Works Progress Administration program.

Relative to applications for snow plowing.

After thorough discussion it was felt that these petitions should be held and considered at a time when the snow plowing program for the entire County is considered and recommend that these petitions be so held.

Relative to communication from P. A. LeClaire, County Clerk of Delta County, in regard to legislation affecting the McNitt Roads.

We recommend that the communication be received and placed on file.

Relative to communication from J. W. Peterson, Supervisor of Forsyth Township.

This matter was referred to the Superintendent of the Board of County Road Commissioners with a request that he write a letter to the Board of Supervisors covering the same.

We recommend concurrence in the above report.

Ishpeming, Mich., Aug. 14, 1935.

Honorable Board of Supervisors,
Marquette County, Michigan.

Gentlemen:--Your Committee on County Parks and the Board of County Park Trustees met on August 14, 1935 and viewed the Gwinn Park, the Champion Beach Park, and the Marquette County Airport, between Negaunee and Marquette, and the Ishpeming Intermediate Landing Field, in the vicinity of Dexter.

We found the Parks in good condition and being utilized very generally by the public. The attendance at Champion Beach Park shows a considerable increase in both day visitors and campers over the preceding year. Both Parks are properly manned and are kept in good condition and the customary facilities are all being provided.

The camping attendance at Champion Beach Park has been running over 50 tents or upwards of 150 to 200 people per night. Day attendance reached 6500 one day and large attendance days are occurring frequently. The life guard service has had more than the usual requirements placed on it during the summer and has made three rescues which would probably have been fatal had they not been in attendance.

We found well constructed landing areas in both the County and the Dexter airports and while they were not mowed at the date of attendance we found that mowing had been arranged for and would be attended to. There was one airship at the County port when we were in attendance. We learned that ships were calling quite frequently at this airport and that the calling ships are very much discommoded by the inability to secure gasoline and oil service, and storage on either field.

We wish to commend the service and recommend continuing the annual appropriation for the conduct of these Parks and airports.

To the Honorable Board of Supervisors:

We submit the following forecast of expenditures for the year 1936. These figures are based on current prices, that appear to have become well stabilized.

When you compare this budget with that of 1935 you will find that it calls for a reduction of \$7,800.00 over the previous year; you will notice decreases under several headings; the few increases are due to necessary replacements.

State Aid money is now coming quite regularly every month; we expect this will continue throughout 1936, thus giving our Sanatorium a considerable income.

The important factor for you to consider in the increase in appropriation asked for last year and now from \$20,000.00 to \$50,000.00 is that one year ago we had the benefit of \$40,000.00 cash on hand which is not available at this year end. This large amount of cash on hand one year ago was due to the fact that the State had paid its arrearages in 1934.
