WHEREAS, the pharmaceutical drug costs are increasing faster than the medical inflation rate;

WHEREAS, the pharmaceutical drug costs are projected to increase rapidly because of the aging population, drug treatments for medical conditions, and marketing and product development costs; and

WHEREAS, the State of Michigan has joined with other states in a purchasing program for pharmaceutical drugs; and

#### MAC PILT RESOLUTION

WHEREAS, The State of Michigan executive budget recommendation on the payment in lieu of taxes (PILT) includes the recommendation that property purchased by the Department of Natural Resources (DNR) is to be treated the same as swampland for tax purposes, at the rate of \$2.00 per acre, and

WHEREAS, The DNR currently owns 66,889.19 acres in Marquette County with a total tax bill of \$174,648.98, and

WHEREAS, The change proposed by the D.N.R. continues the erosion of the local tax base, removing even more property from the ad valorem roll, and

WHEREAS, Local schools and ISD would lose, as their portion of the receipts would go to the County and Township. (Of the \$2.00 per acre, the County gets \$1.00 and the Township gets \$1.00) School Debt could really suffer in some areas, and

WHEREAS, The \$2.00 per acre is fixed. After a few years inflation would eat up the small amount that we "gain" and we would lose like everybody else, and

WHEREAS, The proposal for cuts in PILT payments will jeopardize public services provided to state owned lands and could also force higher tax rates on individual taxpayers, and

WHEREAS, Marquette County officially opposes the Administration's proposal for PILT funding and strongly urges the Legislature to maintain the current process of DNR PILT payments, and


THEREFORE, BE IT RESOLVED, that Marquette County supports funding the payments by utilizing any and all possible funding, including restricted funds and revenue from the sale of state lands.

BE IT FURTHER RESOLVED, that Marquette County also supports efforts to streamline tax bills so the DNR gets just one bill from each county and supports letting local governments get sign off whether the DNR can purchase land in its jurisdiction, and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded to Governor Jennifer Granholm, all Upper Peninsula Legislators, and the Michigan Association of Counties.

WHEREAS, the County of Marquette aims to protect the health, safety, and well being of its residents; and

WHEREAS, the County of Marquette is in the process of creating a Wellhead Protection Plan for the K.I. Sawyer Community water supply; and

WHEREAS, the County of Marquette is applying for a Michigan Department of Environmental Quality Wellhead Protection Grant for 2004;

NOW THEREFORE BE IT RESOLVED, that the Marquette County Board of Commissioners hereby supports the idea of Wellhead Protection and Wellhead Protection Planning for the K.I. Sawyer Community water supply.

10c) The County Board considered a Committee of the Whole Recommendation regarding movement of caving ground fences. The Committee of the Whole recommended the County Board refer the matter to legal counsel for an opinion regarding possible liability to the County and the County Mine Inspector and how the County and/or Mine Inspector can proceed. Paul Bleukamp, a geologist with 30 years experience in Marquette County conducted a safety survey of the area.

Mr. Bleukamp was present to answer any questions the County Board may have. He explained he has prepared maps for the cities showing where, in his opinion, it is safe to occupy the property and outline the areas where fencing should remain forever as far as he is concerned. He explained there is a misconception concerning caving grounds by the public. Most property can be utilized.

Harley Andrews, Civil Counsel, explained to the County Board they have no role in making any determination as to whether or not there is or is not caving ground or whether there is danger or no danger. The questions the County Board is being asked to address by the Mine Inspector is the potential liability to the County and the Mine Inspector if the Mine Inspector makes an erroneous judgment or if he has the authority to make any judgment at all and secondly, how to mitigate that potential liability if there is any. Mr. Andrew further explained he is working on the opinion and he will have it for the County Board of Commissioners at their next Committee of the Whole meeting.

It was moved by Comm. Nordeen, seconded by Comm. Arsenault, and unanimously carried by voice vote that the County Board refer the matter to legal counsel for an opinion regarding possible liability to the County and the Mine Inspector and how the County and/or Mine Inspector can proceed.

10e) The County Board considered a Committee of the Whole Recommendation regarding Airport Law Enforcement. The Transportation Security Administration has terminated the current Memorandum of Agreement with Marquette County. The agreement provided reimbursement for checkpoint law enforcement officer services. Funded has ended but the federal mandate continues. It is the Commissioners' understanding that the 20-minute requirement is an arbitrary standard TSA has carried forward from the Federal Aviation Administration. If the law enforcement officer can respond in 20 minutes, the mandate has been met. If the response exceeds 20 minutes, TSA will impose an \$11,000 fine and may suspend scheduled flights. Commissioners suggested that the TSA or Congress consider a waiver of the 20-minute requirement for Category IV airports.

The Committee of the Whole recommended the County Board send a letter to our Legislators advocating for a change in TSA's flexible stationing requirement. They further recommended to the County Board that the Marquette County Sheriff's Department continue with airport law enforcement at its current level with two officers per day, one working the a.m.  $\sinh t - 5:00$  a.m. to 1:00 p.m., the second officer -1:00 p.m. to 8:00 p.m. through June 30, 2003.

Steve Powers, County Administrator, met with the Undersheriff, Road Patrol Captain, and the SIA Director to review the Committee of the Whole June 10<sup>th</sup> recommendation. The conclusion is the flexible response (20 minutes) can and should be implemented June 18<sup>th</sup> if the Board chooses to modify the Committee of the Whole recommendation. The Sawyer Deputies and Road Patrol will respond. The Sheriff's Department is committed to making the flexible response work. By labor contract, the County must provide deputies 14-days notice of layoff. If the Board chooses to terminate the Airport law enforcement effective June 18<sup>th</sup>, the two officers currently assigned to the terminal would be reassigned to other duties until the layoff took effect July 2<sup>nd</sup>. If the Board chooses to follow the Committee's recommendation, the Airport Deputies would continue at the terminal through June 30<sup>th</sup>.

It was moved by Comm. Arsenault, seconded by Comm. Cihak, and unanimously carried by voice vote that the County Board modify the Committee of the Whole Recommendation and implement the flexible response time (20 minutes). Sawyer Deputies and Road Patrol will respond.

101) The County Board considered acceptance of construction bid for Building 500 roof replacement at Sawyer International Airport and Business Center. The roof is leaking in numerous locations and needs to be replaced immediately to prevent additional water damage and mold growth. Funding is available in the Sawyer Business Center, Building Repair Fund to cover the cost of the replacement.

The project was advertised in the Mining Journal and sent to the Marquette and Delta County Builder's Exchanges. The lowest response was from Bell Roofing Company for \$19,883. Bell Roofing Company meets the requirements set forth in the RFP. The County has a current contract with Bell Roofing Company for Building 632 and 634 roof replacement. Steven Schenden, Project Manager, recommends Bell Roofing Company be awarded a change order to replace the roof on Building 500.

It was moved by Comm. Wallace, seconded by Comm. Tuominen, and unanimously carried by voice vote that the County Board award the Construction Bid for Building 500 Roof Replacement to Bell Roofing Company for \$19,883.

Chairperson Corkin opened the meeting for public comment, none was forthcoming.

Comm. Tuominen and Chairperson Corkin spoke briefly regarding the Marquette County Road Commission. The Road Commission has been working hard in the Silver Lake Area since the Dead River Flood. They explained that the various agencies are working well together and thanked everyone for their cooperation.

Chairperson Corkin announced there will be a Dead River Flood Public Forum, Thursday, June 26, 2003, 7:00 p.m. to 9:00 p.m., Negaunee Township, 42 M-35, Negaunee, MI. Discussion topics will include an update on recovery efforts underway or planned, what property owners can and cannot do, and questions from the audience. There may be questions concerning organizations and people may be asked to participate in a panel discussion prior to questions from the audience. The Upper Peninsula Power Company, the Michigan Department of Environmental Quality, the Michigan Department of Natural Resource, and the Central Lake Superior Watershed Partnership are panel participants.

Comm. Wallace announced there will likely be between \$200,000 and \$220,000 coming through the Federal Office of Emergency Preparedness. The State Department of Community Mental Health is working with MAC and the Michigan Association of Local Public Health Agencies (MALPH) helping to come up with a formulation on how to dispense the federal money that is coming to the State for emergency preparedness purposes.

There being no further business, the meeting was adjourned at 7:35 P.M.
