Over 2000 Students

Summer Session Enrollment Largest Ever Registered

A record 2160 students have thus far enrolled in Northern Michigan University's Summer Session according to Anthony H. Forbes, Director of Summer Session.

The present 2160 enrollment figure includes only those registered for the eight week regular summer session and the first four week session Dr. Forbes pointed out.

"On this basis," Dr. Forbes said, projecting the enrollment for the second four week session and the post-session to be conducted, "I estimate a final enrollment of 2250 for the full 1968 Summer Session."

Forbes said the present enrollment of 2160 "represents a 5.1% increase over the 2,006 enrolled at a comparable date last year."

The bulk of the 2160 enrolled thus far in summer school are attending classes on campus with the rest enrolled at Northern's three residence centers, Forbes said. He said 1930 are registered on campus, 112 at K. I. Sawyer AFB, 77 at Iron Mountain-Kingsford, and 42 at Kincheloe AFB.

Northern's summer session has been patterned to meet the needs of almost anyone seeking additional undergraduate or graduate credit,

with more than 200 courses being offered in the varying length sessions in the combined two four-week sessions, the regular eight-week session, and the post-session. Also being held at Northern during the summer are several special institutes and workshops.

Those planning to register in the second four-week are reminded that it begins July 12. The post-session courses in business, biology, education, English, industrial education, mathematics, music, psychology and visual arts begins August 12 and will run to August 23.

Workshops and institutes to be held during the summer school include NMU's 22nd annual coaching school, Aug. 8-10; the 18th annual summer music camp for junior and senior high school students, Aug. 11-17, a high school debate

workshop, Aug. 12-23; and two National Science Foundation sponsored programs.

There are presently being conducted a pre-college science program for high school juniors which began June 16 and will run until July 28 and an institute in geometry for high school teachers which began June 17 and will conclude August 9.

University Reinstates Dr. McClellan

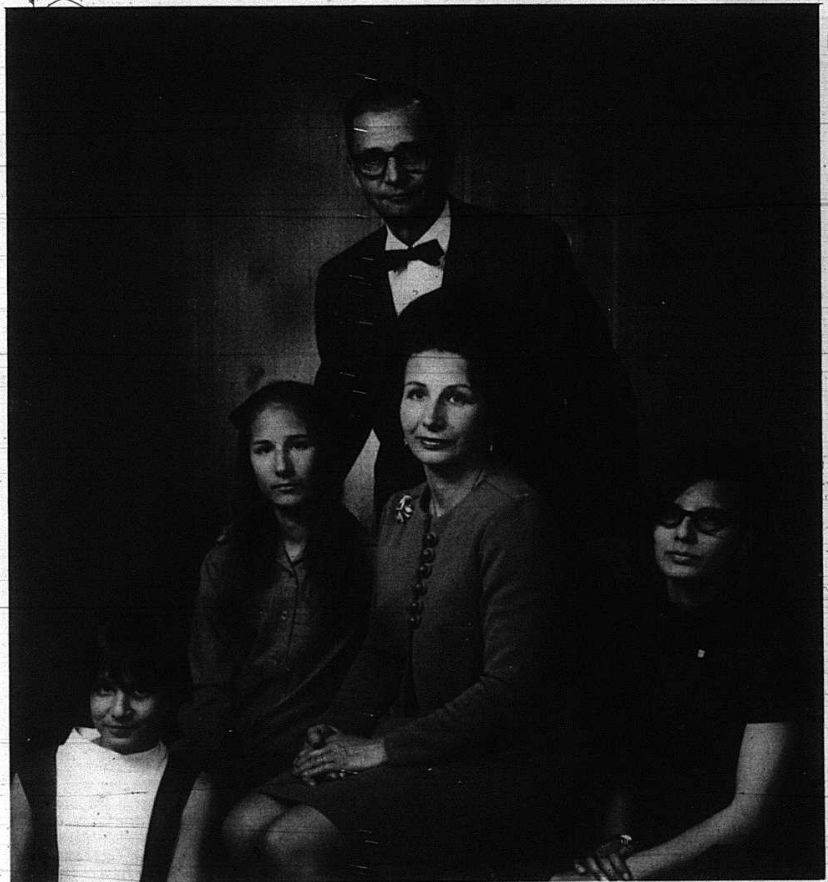
An out-of-court settlement has been reached in the case of Dr. Robert McClellan against NMU officials which calls for reinstatement of the history professor for the 1968-69 academic year and for dismissal of the litigation.

The case, in which McClellan contended his civil rights were violated along with academic freedom of the faculty as a result of the termination of his contract at the end of June was to have been tried in U.S. District Court in August.

Marvin Heitman, McClellan's attorney, and George Hill, attorney for NMU, declined any comment on the case beyond a statement issued by the office of George E. Bushnell Jr., Detroit attorney employed by NMU to defend it against McClellan's suit.

The statement pointed out that during the past year NMU has been faced with a "number of serious issues stemming from the non-reappointment" of Dr. McClellan.

It went on to say that "the welfare of the University is paramount and with the conviction that academic issues are best resolved within the academic setting, the parties to the suit have agreed to an out-of-court settlement" and it also made note of Dr. McClellan's reinstatement for the academic year of 1968-69.

Dr. John Jamrich Takes Over As University's New President

Northern Michigan University greeted the seventh president in its 69 year history yesterday as Dr. John X. Jamrich officially assumed his new position as president of the university.

The initial announcement of the selection of Dr. Jamrich was made by the Board of Control last March to take effect July 1.

Dr. Jamrich, his wife June, and their three daughters have taken up their residence in the remodeled president's home.

Dr. Jamrich who comes to Northern from an associate deans post at Michigan State University has put

a high priority on his decision to call for three major faculty studies at NMU next fall.

He has stated and restated his intention to appoint a committee on the future of the university, a task force on academic governance at Northern, and a task force (consisting of both students and faculty) on student rights and responsibilities at Northern.

Last spring, speaking before a meeting of the Student Government Association of NMU, Dr. Jamrich replied to the SGA's three student supported referendums, one of which had to do with student rights.

At that time Dr. Jamrich pointed

out that their Student Bill of Rights fell short of its goal because it failed to consider the rights of faculty and others. He brought forth many supporting statements and then brought it to the attention of the SGA that he intended to form a committee containing students and faculty in the fall, to study this problem of student rights and responsibilities.

Dr. Jamrich has said that he believes a "University is not only a corporate body governed under appropriate statutes by a duly constituted governing board, but it also
